RESOLUTION APPROVING AN AMENDMENT TO THE FY 2009-2014 TRANSPORTATION IMPROVEMENT PROGRAM (TIP) THAT IS EXEMPT FROM THE AIR QUALITY CONFORMITY REQUIREMENT TO ADD FUNDING FROM THE AMERICAN RECOVERY AND REINVESTMENT ACT FOR FOURTEEN PROJECTS AS REQUESTED BY THE FEDERAL HIGHWAY ADMINISTRATION -EASTERN FEDERAL LANDS DIVISION

WHEREAS, the National Capital Region Transportation Planning Board (TPB), which is the metropolitan planning organization (MPO) for the Washington Region, has the responsibility under the provisions of the Safe, Accountable, Flexible, and Efficient Transportation Equity Act - A Legacy for Users (SAFETEA-LU) of 2005 for developing and carrying out a continuing, cooperative and comprehensive transportation planning process for the Metropolitan Area; and

WHEREAS, the TIP is required by Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) as a basis and condition for all federal funding assistance to state, local and regional agencies for transportation improvements within the Washington planning area; and

WHEREAS, on November 19, 2008 the TPB adopted amendments to the FY 2009-2014 TIP which was adopted on July 16, 2008; and

WHEREAS, on February 17, 2009, the American Recovery and Reinvestment Act of 2009 (ARRA), which includes substantial new funding for the nation's transportation system, was enacted; and

WHEREAS, in the attached letter of March 12, 2009, the Federal Highway Administration (FHWA) - Eastern Federal Lands Highway Division has requested an amendment to the FY 2009-2014 TIP to add \$74,044,000 in ARRA funds for the regular Federal Lands Highway Program for Park Roads and Parkways and for National Park Service transportation improvements, and

WHEREAS, \$23,293,000 in ARRA funds are programmed for five projects in the District of Columbia, \$40,391,000 in ARRA funds are programmed for four projects in Maryland, and \$10,360,000 in ARRA funds are programmed for five projects in Virginia, as described in the attached materials; and

WHEREAS, these projects are exempt from the air quality conformity requirement, as defined in Environmental Protection Agency (EPA) regulations "40 CFR Parts 51 and 93 Transportation Conformity Rule Amendments: Flexibility and Streamlining; Final Rule," issued in the May 6,

2005, Federal Register;

NOW, THEREFORE, BE IT RESOLVED THAT the NATIONAL CAPITAL REGION TRANSPORTATION PLANNING BOARD amends the FY 2009-2014 TIP to add \$74,044,000 in American Recovery and Reinvestment Act (ARRA) funding for fourteen projects, as described in the attached materials.
