In April 2019, LEED for Cities and Communities v4.1 was launched. Version 4.1 is a merger of LEED with the STAR Communities Index and offers a comprehensive framework to support planning, design, operation, and performance of cities and communities at the forefront of combating climate change. There are six LEED categories including Natural Systems and Ecology, Transportation and Land Use, Water Efficiency, Energy and Greenhouse Gas Emissions, Materials and Resources, and Quality of Life.

**11:20 A.M. 5. CLEAN ENERGY RESILIENCE: RESIDENTIAL SOLUTIONS**  
*Edward Yim, District Department of Energy and Environment*

The District of Columbia is implementing engineering solutions aimed at providing energy resiliency for homes and residential neighborhoods. The solutions can be made available and applied in other jurisdictions. The first solution is a standardized design for an islandable single home with rooftop solar panels and a powerwall battery. The second product, is a cost-effective, streamlined approach to an islandable residential neighborhood microgrid (about 200 homes) powered by rooftop solar panels and a centralized battery system.
