The Biden-Harris Administration announced on September 27, 2022 that it has approved Electric Vehicle Infrastructure Deployment Plans for all 50 States, the District of Columbia and Puerto Rico ahead of schedule under the National Electric Vehicle Infrastructure (NEVI) Formula Program, established and funded by President Biden's Bipartisan Infrastructure Law (BIL). With this approval, all states now have access to all FY22 and FY23 NEVI formula funding, totaling more than \$1.5 billion to help build EV chargers covering approximately 75,000 miles of highway across the country. DDOT, MDOT, and VDOT representatives will brief the committee on their respective plans.
