Round 8.4 is voluntary and some jurisdictions chose not to make any changes to their population, households, or employment data.

COG staff received four submissions detailing changes to their jurisdiction's Benchmark Totals:

- **Arlington County**
- **City of Alexandria**
- **Fairfax County (Population and Households Changes Only)**
- **Prince William County**

Other submissions include:

- New data for Anne Arundel, Carroll, and Howard Counties from the Baltimore Metropolitan Council (BMC Round 8A).

- **COG Board will approve “Draft Round 8.4” for use in the Air Quality Conformity Analysis of the 2015 Update to the Financially Constrained Long-Range Transportation Plan (CLRP) and the FY 2015-2020 Transportation Improvement Program (TIP) – February 2015**
- **Final approval and adoption by the COG Board - October 2015**
