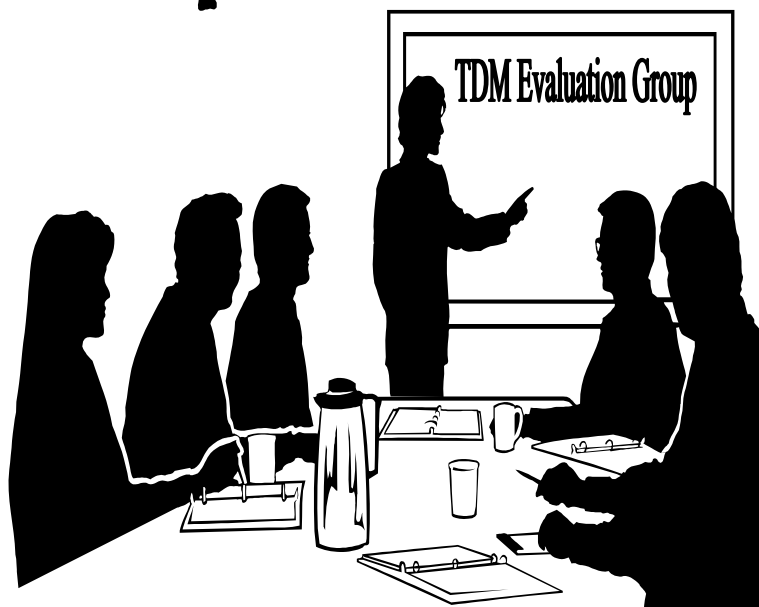

**TERM ACTIVITIES/DATA COLLECTION
COMPLETED AND TO DO BY TERM
NOVEMBER 24, 2004**

Following are data collection and analysis activities that have been completed and those yet to be completed. All analysis is planned to be completed by end of May 2005 and a draft TERM Analysis Report will be prepared during June 2005. Because analysis of many TERM components requires data from Commuter Connections databases and other tracking tools and the analysis will be conducted primarily during March through May 2005, this report will estimate benefit only through DECEMBER 31, 2004. During July-September 2005, the report will be updated to include data for the final six months of the three-year evaluation period (January-June 2005).

Telework Resource Center (TRC)
