# Whistle Stop Tour Events

# NSSE Operating Environment

- Attendance at key DC events estimated at over 2 million people
- Weather Predictions – January 17-20
  - Much colder air, middle and latter part of this week
  - Below zero wind chills possible
  - Potential snowfall in the east
  - Statistical Climatological Temp Range –
    - Low mid 20 °s – High in low 40 °s
    - Noon Conditions: 37° – Partly Cloudy – Wind 10 MPH
    - Precipitation - 1:6
    - Snow - 1:20
- Transportation
  - Highway congestion regionally
  - Public transportation stressed to capacity
- Housing/Lodging
  - Hotel rooms are not available
  - Shelter capacity challenges
- Medical system capacity (facilities, staff, and transport) challenges
  - Impediments to movement (access, egress)
- Communication system capacity issues (public/government)
- Extraordinary security challenges
- Intense media coverage
- Unforeseen consequences from interdependencies

# Law Enforcement and Military Support

- DC Metropolitan Police
  - 4,000+ law enforcement personnel from DC Metropolitan Police will be on duty
  - 4,000+ additional troops will be available in adjacent states
- National Guard
  - 10,000 guardsmen have been assigned to DC of which 7,000 will be on the National Mall
  - 1,100 guardsmen will be on duty in adjacent states for traffic control
  - 800 guardsmen will be stood up from Joint Task Force 29
  - 16,000 will be available within 24-48 hour notice

# District of Columbia, Virginia and Maryland Actions

## District of Columbia

- **DC HSEMA EOC Hours of Operations**
  - Full Activation 1800 hrs. January 16 to 1800 hrs. January 22
  - Mobile Command Post to be located within USSS Secure Zone (The National Mall area)
- **DC leading planning effort for issues arising from the huge crowds expected**
  - Working groups established with support from FEMA Subject Matter Experts (SMEs)
- **DC HSEMA leading working groups to develop integrated local/state plan with NCR and FEMA partners**
  - Transportation & Evacuation
  - Joint Information Center / Messaging
  - Sheltering

## Virginia

- VEOC will be operational and have augmented staffing. Hours of operation yet to be determined.
- NoVA localities are reviewing their capability to backup the NCR.
- Transportation coordination with DC
- The NoVA Evacuation Plan will guide evacuation efforts if necessary.
- NoVA PIO are participating in the Inauguration Planning groups. Intend to partner in both JIC and messaging efforts.

## Maryland

- Maryland State Emergency Operations Center will be staffed at Level 3 from the evening of January 17th – 7pm through the morning of January 21 – 7am
- MEMA as state agency designee holding weekly meetings and conference calls with State Staff. MEMA will hold Inaugural Exercise on January 9th
- State of Maryland is participating in weekly Consequence Management Subcommittee, Evacuation/Transportation, Sheltering and JIC/Messaging Working Groups
- State meetings held with local jurisdictions on local evacuation plans to ensure coordination with DC

# Delaware, Pennsylvania, West Virginia Actions

- All Region III States have been included in the planning efforts
- Delaware and Pennsylvania are planning for NSSE events with partners for January 17<sup>th</sup> events
- Region III States are coordinating evacuation and sheltering needs



# Request for Assistance

\*Condensed List as of 09 January 09

- Surge sampling, to include resource support and funding, from the BioWatch Program.
- Assignment of a Civil Support Team with experience working with the United States Secret Service during NSSEs to assist the BioWatch surge.
- Provide security escort to the BioWatch/CST collection teams while they access their collectors.
- Transportation of 20-30 DOI Law Enforcement Officers and personal equipment from their primary duty station in the Pacific West Region
- 3 Ambulance Strike Teams for Inauguration Day Event Support
- 1,300 National Guard Troops to assist with the law enforcement along the Inaugural Parade Route and the areas of the National Mall that are affected by the Inaugural Event.
- Technical expertise and assistance in planning radiological support capable of sweeping venues in advance of public or protectee occupation and screening of personnel entering through identified checkpoints; and manpower and equipment to properly staff and execute the radiological protection plan
- 2 Type I Urban Search and Rescue Teams
- Support of the National Medical Response Team
- Support of the Naval Research Laboratory CT-Analyst real-time plume assessment team for the security arrangements being organized for the Presidential Inauguration.
- Aerial Electro-Optical Infrared (EO/IR) Full Motion Video (FMV) Support.
