COG Activity Center Names

At the Revitalization Committee Meeting on October 2, 2012, the Board of Supervisors directed staff to evaluate whether COG's draft Activity Center names along the Silver Line (Activity Centers 95, 96, 97, 98, 99, 100, 101 and 102) should be the same as the newly adopted Metro station names. In addition, the Board indicated that the name for Activity Center 113 should be updated, which will change its name from "Engineers Proving Ground" to "Fort Belvoir North Area."

Tysons Follow-on Motion #3 recommends that the Tysons Partnership should initiate a process to review and potentially change district names to enhance community character and identity. Staff anticipates working with the Partnership to address this issue in 2013. Therefore, staff recommends that the COG Activity Center names continue to reflect the district names in the adopted Comprehensive Plan for now.

The areas around the remaining four Silver Line stations are under study by the Reston Master Plan Special Study Task Force and the Route 28 South Work Group. Since these studies are anticipated to recommend changing the Comprehensive Plan Transit Station Area names to be the same or similar to the Metro station names, staff recommends that the names of these COG Activity Centers be changed to the Metro station names.

Unless otherwise directed by the Board, DPZ staff will provide the recommended Activity Center names, summarized on page 2, to COG staff.
