**1. REVIEW AND APPROVAL OF PROJECTS RECOMMENDED FOR FUNDING UNDER THE FEDERAL HIGHWAY ADMINISTRATION'S CHARGING AND FUELING INFRASTRUCTURE DISCRETIONARY GRANT PROGRAM AND AN AMENDMENT TO THE FY 2023-2026 TRANSPORTATION IMPROVEMENT PROGRAM**

The Steering Committee will be briefed on projects recommended for funding under the Charging and Fueling Infrastructure (CFI) Grant Program. On August 27, the Federal Highway Administration (FHWA) announced that Round 1B of their Grant Award Recipients included a \$3.9 million award to the Metropolitan Washington Council of Governments (MWCOG). The committee will be asked to approve the recommended projects and an amendment to the FY 2023-2026 Transportation Improvement Program (TIP) to include this funding.

**Actions:**

- Adopt TPB SR18-2025 approving the projects recommended for funding under FHWA's CFI grant program and to amend the FY 2023-2026 TIP to include these projects.

**Actions:**

- Adopt TPB SR19-2025 to amend the TIP to include TIP Action 23-49.1 which adds funds to the William Howard Taft Memorial Bridge Rehabilitation project and funds for a new study to address flooding of the Nannie Helen Burroughs Avenue underpass at DC-295, as requested by DDOT.
- Adopt TPB SR20-2025 to amend the TIP to include TIP Action 23-49.2 which adds funding to MDOT's National Electric Vehicle Infrastructure (NEVI) program, two bridge replacement projects, a highway reconstruction project, and a bicycle/pedestrian, safety and accessibility improvement project, as requested by MDOT.
- Adopt TPB SR21-2025 to amend the TIP to include TIP Action 23-49.2 which includes funding for a new study of a pedestrian/bicycle bridge over CSX and Metrorail tracks in the Twinbrook community, as requested by the City of Rockville.
