Dear Mr. Kirby,

2005 was an exciting year as we finally saw the passage of the Safe, Accountable, Flexible, Transportation Equity Act – A Legacy for Users (SAFETEA-LU). AMPO staff worked diligently with Hill staff and consultants to ensure an increase in PL funding from 1% under TEA-21 to \$1.25% in the new Bill.

Prior to the passage of SAFETEA-LU, AMPO staff, board members, and committee members began focusing on TEA-4 and the future of MPOs. The 2005 Annual Conference, which drew over two hundred participants, focused on this particular topic with a three part series on Ensuring MPO Relevance. AMPO is dedicated to the advancement of MPOs and will continue to think strategically about the future.

We continue to utilize our Federal grants to provide members with technical assistance. New this year, AMPO partnered with FTA to award Safety & Security Challenge Grants to three MPOs, totaling \$125,000, to develop innovative projects that address safety and security in the transportation planning process. We are currently working on two additional grant awards for emergency/disaster response planning at the regional level.

Since 1999, AMPO has continued to grow and to improve its' services. In 2005, we grew to two hundred and fifteen members, with twenty-five organizations joining during this year alone. In order to continue to provide the most up to date policy information, technical assistance, and other member services including professional publications and conferences, the AMPO Board of Directors approved a membership dues increase for 2006. The formula for calculating dues has changed from 2000UZA x .005 to 2000UZA x .0055 and the dues cap has been increased from \$18,750 to \$19,750. Your new dues are calculated on the actual invoice.
