#### a. <u>Commercial Aircraft Noise Monitoring</u>

Recently there have been several requests for noise monitoring stations in communities impacted by aircraft over flights. These communities are located well outside of the 65 Ldn contour, but, nevertheless, over flights continue to impact these areas. The Committee will be asked to formally request that MWAA consider mobile monitoring of these areas and to develop feasibility options for expanding the existing 40 station noise monitoring system.

#### b. <u>Helicopter Noise Monitoring System</u>

In March 2007, over 50 pilots and federal and local government representatives participated in an information exchange forum to address helicopter noise impacts on communities in the Metropolitan Washington Region. One of the outcomes of this forum was an agreement that the commander for military operations would be point of contact for all military noise complaints. This arrangement has worked to some degree over the past months. However, there is still no centralized or formal process for reporting and/or resolving helicopter noise complaints within the Washington Region. The Committee will be asked to recommend that a proposal for development of a helicopter noise monitoring system be submitted as part of the CASP. The proposal should also include analysis of over 80 helicopter noise complaint recently collected and submitted to the military.

The Federal Aviation Administration (FAA) supports initiatives by States and Metropolitan Planning Organizations (MPO) to participate in the Continuous Airport Planning Process (CASP). The goal of the CASP program is to provide a process that supports the planning, development, and operation of airport facilities and other transportation facilities that serve the airports in a systematic framework for the region. In support of the CASP program, a five-year Airport Capital Improvement Plan (ACIP) is developed, that schedules airport-related studies for which Federal funding will be sought. COG Aviation Technical Committee is currently updating the ACIP.

Mr. Nichols and Mr. Griffiths will brief the committee on the process and timeline.
