The Northern Virginia Transportation Authority (NVTA) is in the early stages of updating its long-range transportation plan and is exploring relevant lessons from the COVID-19 pandemic that may affect its approach. Over the summer, NVTA analyzed the potential transportation impacts of COVID-19 using four 'scenarios' for both short- and medium-term horizons. The four scenarios reflect different assumptions regarding work from home, transit safety perception, e-commerce, etc. This presentation describes the scenarios and summarizes the findings of the analysis. Underlying scenario assumptions are compared with selected findings of several recently published surveys.
