The new initiative provides local stakeholders, including foundations, businesses and individuals, an opportunity to be part of the solution through impact investing. The goal of Our Region, Your Investment is to invest a minimum of \$5 million in capital to support the production and preservation of affordable homes in the greater Washington region.
