Why the HDIP?

Ending homelessness is a very complex issue that requires many tools to achieve positive results. The Commonwealth is a national leader in implementing best practices and innovative strategies to end homelessness. To continue the progress, it is imperative that Virginia use comprehensive and timely data to optimize systems of care with data driven decisions.

Homeless Data Integration Project (HDIP)

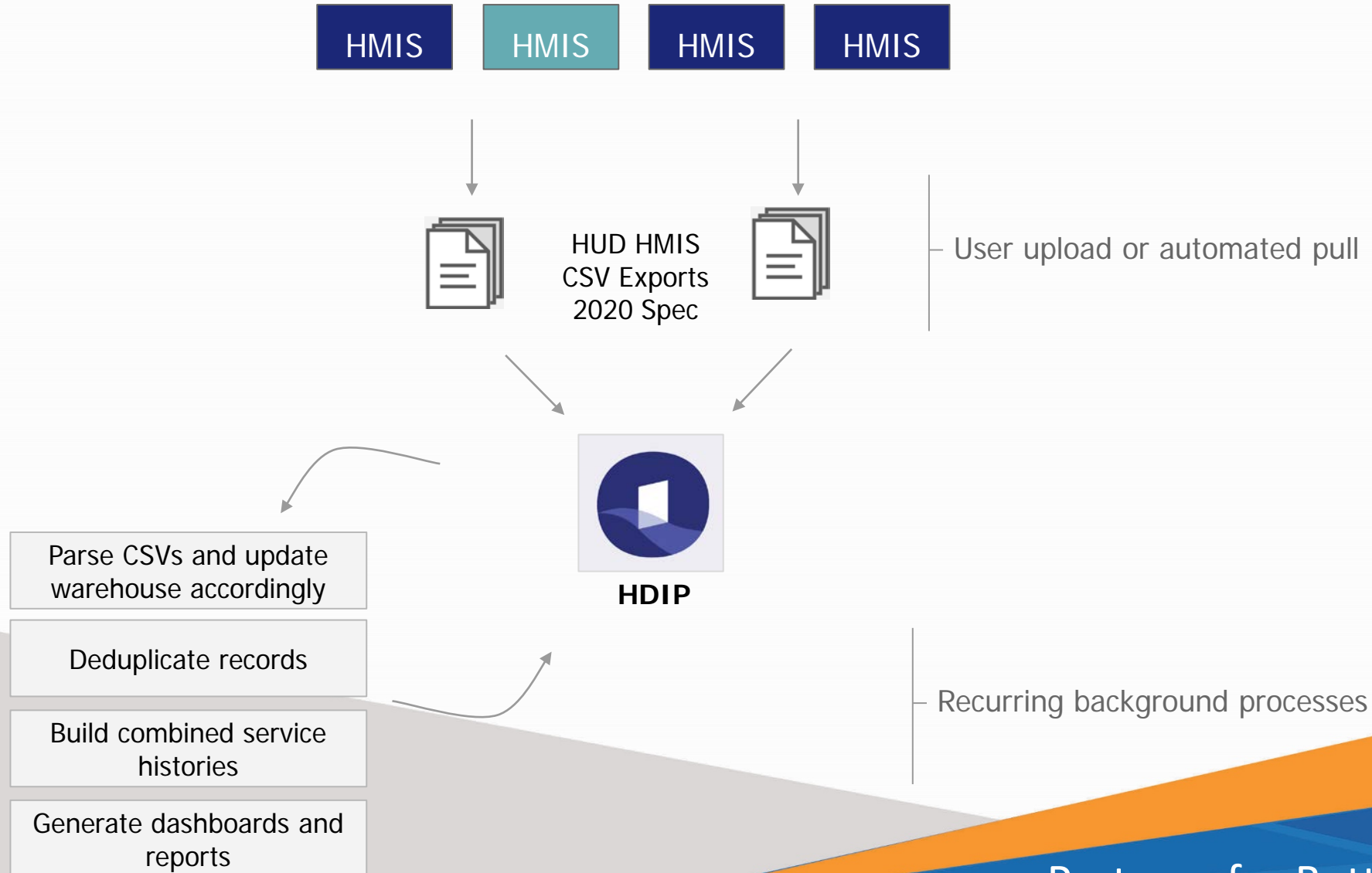
- Goal:

- Establishment of a homeless data integration warehouse that allows state policy makers, DHCD, and other stakeholders (specifically, CoCs and LPGs) the ability to use comprehensive and timely data to end homelessness.

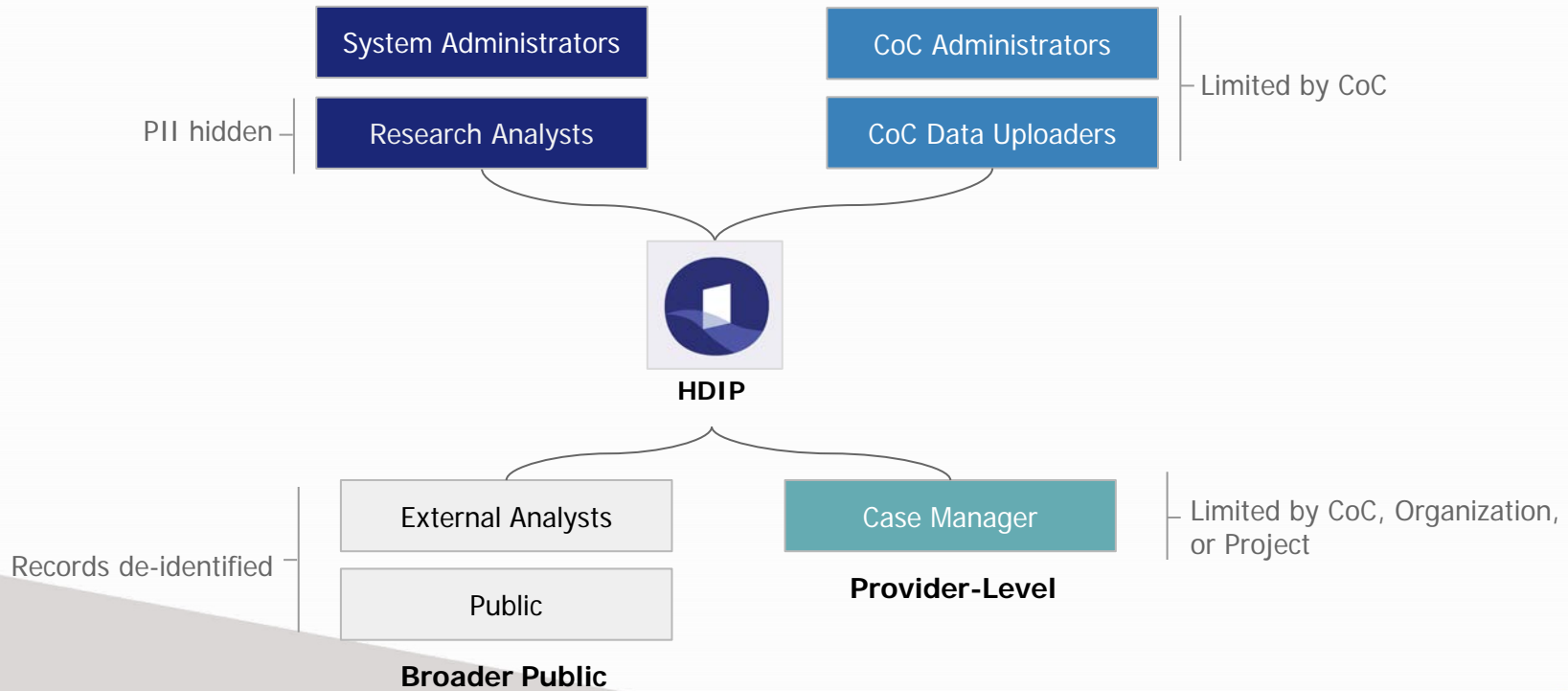
Homeless Data Integration Project

- Concept:
 - Think of the project as an extension of HMIS
 - Project will integrate HUD Data Standards (HUD CSV Report) from each CoC's Homeless Management Information System (HMIS) into the HDIP software platform (Open Path, Green River, Inc)

Benefits for All

- Communities will gain:
 - Access to near real-time data that will enable them to respond to trends
 - Ability to drill down on populations and projects to address important and timely questions
 - Opportunity to match data with other systems of care to generate support and resources
 - Opportunity to better partner with other service providers
 - Flexibility in reporting tools

Benefits for All

- The Commonwealth will have:
 - Statewide and local views of homelessness
 - A better understanding of community needs
 - Opportunities to identify community successes
 - Opportunities to drive sustainable partnerships with other systems of care
 - The ability to create reports at the statewide level

HDIP Outcomes

- Understand and present information on the homeless population in Virginia to a variety of constituencies — policy makers, other state systems of care, and the public.
- See inflow, outflow, length of time homeless, and other system performance measures across CoCs and LPGs for TA or to highlight best practices and positive outcomes.
- Work with CoCs to identify and manage data quality issues.
- Work with CoCs to prioritize housing opportunities for the most vulnerable individuals.
- Understand and use collected homeless data to guide statewide initiatives.

Use Cases

CoC Lead

- Compare local CoC performance with state population
- Identify inflow, outflow, length of time homeless trends
- Investigate advocacy's assertion that certain populations are not seeking services
- Identify potential issues of service inequity
- Glean additional analytic insight than what's available in local HMIS reports

HMIS Administrator/Lead

- Track project performance
- Provide organizations feedback on data quality
- Have additional tools for investigating and generating reports for the CoC, the state, and HUD

Case Manager

- Verify chronic homeless status
- Understand someone's homeless service history
- Access shared critical documents

Project Members will only share client PII and client information based on the Data Sharing Agreement, this Participation Agreement, HIPAA, other Business Associate Agreements with other parties, or if required by state or federal law. If a Project Member chooses not to allow its CoC to share information in accordance with the Data Sharing Agreement, a Project Member may add an addendum to this agreement and the HMIS Lead will work with DHCD and Green River to set security protocols accordingly.
