SUBJECT:	TPB Long-Range Plan 2022 update, schedule

This memorandum provides a proposed schedule for the Visualize 2045 Long-Range Transportation Plan 2022 Update, including key dates regarding DOT/DRPT/WMATA inputs and communications for agency consideration and feedback.

## BACKGROUND

The update to TPB's long-range plan, Visualize 2045, is due for federal approval December 13, 2022. To allow for additional time for federal review or unforeseen circumstances that might impact TPB approval of the plan update, the Department of Transportation (DTP) staff are intending to complete the plan approximately six months prior to the federal deadline.

The plan schedule is extended by several months compared to the 2017/2018 cycle (from the call for projects to anticipated TPB approval date of the long-range plan 2022 update). This additional time in the schedule to allow for:

- an advance call for projects notification to TPB members, with extended input submission window
- additional opportunity for the TPB to provide guidance on the response to public comments on the technical inputs and draft final plan; and
- to allow an additional month for the air quality analysis as the DTP staff anticipate there might be changes to the analysis requirements.
