

- LRTPs, TIPs, VIPs, and Air Quality Conformities
- Bicycle and Pedestrian Plan
- Congestion Management Process
- Financial Constraint and Obligation Reporting
- Public access to plan and TIP data via Visualize 2045 website



National Capital Region Transportation Planning Board

- Software as a Solution platform built and customized by EcoInteractive
- Benefits include:
 - Help Desk and ongoing product support
 - Access to continual innovations without need to upgrade
 - Empowers multiple user types to complete multiple processes within one system
 - Increases efficiency by reducing duplicative external steps
 - Increases transparency
 - Standardized and documented processes
 - Everyone sees the same status reports and notifications keep users appraised on next steps



User Eligibility and Types

- Staff from any TPB member agency are eligible to have one of the following types of accounts:
 - **Sponsor** designated agency personnel will have full editing capabilities
 - **Read-Only** some agency personnel may be granted access to view data, but not allowed to edit
- Multi-agency Access
 - Where appropriate, staff from one agency can be provided with read/write or read-only access to records from another agency (e.g. MDOT/SHA can read MDOT-MTA records, or Frederick County can edit records for City of Frederick)
- Federal Reviewers
 - FHWA and FTA review and approve STIP amendments



Implementation Status

- Project InfoTrak went live on June 8, 2020
- Three training sessions provided by consultant, EcoInteractive
 - <u>Session 1 June 9</u>
 - Session 2 June 11
 - Session 3 June 16
 - Additional one-on-one training available upon request
- Data clean-up complete
- Ready to use for amendements and modifications to FY 21–24 TIP
- 2022 Update to Visualize 2045 and the FY 23-26 TIP
 - Coming this winter



In-App Nomenclature

- Adoption initial board approval of a long-range plan or TIP document
 - LRTP 45–00: first two years indicate out-year of plan,
 "-00" indicates initial adoption of Visualize 2045 in 2018
 - 45-22: 2022 Update to Visualize 2045
 - TIP 21-00: first two numbers indicate the first fiscal year (or Annual Element) of the program "-00" indicates initial adoption
- Amendment covers formal amendments to plan or TIP approved by TPB or Steering Committee and administrative modifications
 - LRTP: 45-01 2019 off-cycle amendment, 45-02 amendment approved in conjunction with FY 21-24 TIP
 - LRTP: 45-23 first amendment to 2022 Update of Visualize 2045 (off cycle or scheduled 2-year amendment in 2024)




