 On Thursday, March 11th, President Joe Biden signed the American Rescue Plan Act into law. The new stimulus package includes several items that support housing stability in our region, including funding for emergency rental assistance, housing vouchers, homelessness and homeowner assistance, housing counseling and fair housing support as well as utility assistance. This is in addition to the Emergency Rental Assistance program from the Treasury Department.

- How is your jurisdiction preparing to administer this new round of funds?
- o Are you considering changes to existing programs?
- Is there an opportunity for us to consider piloting a new crossjurisdictional approach to address current emergency needs using federal (vs local) funding sources?
- In addition, the CDC eviction moratorium is also scheduled to end on March 31st – how is your jurisdiction preparing and working to prevent a significant inflow into homeless services?
