1) Block out a week on your calendar

2) Convert Purge Report to Excel, so that you can copy only the emails

3) Send email using Bcc to all on the list

4) If no response in 2 days, then call the **work number only**, (leave message if no answer)

5) Once you have heard from the commuter, go into there account and reregister

6) Make sure you add your notes

7) Send Ridematch if registered for GRH1 or Ridematching

8) If no response, then and only then do you let Commuter Connections send out a notice before they mark them in-active.
