Dear Mr. Dernoga:

The purpose of this letter is to express our concerns about the proposed changes to the Bylaws of the Metropolitan Washington Air Quality Committee (MWAQC) presented September 22, 2004 by the staff of Metropolitan Washington Council of Governments (COG).

The Maryland General Assembly created the Tri-County Council Maryland in 1965. Our enabling legislation states that the Council "shall operate as the cooperative planning and development agency within Calvert, Charles and St. Mary's Counties, to foster the physical, economic and social development of the tri-county area; and initiate and coordinate plans, projects for the development of human and economic resources of the Southern Maryland region as a Southern Maryland planning and development agency." The Council's coordination role in MWAQC clearly supports our legislative mandate.

The current Bylaws clearly define the roles of Tri-County Council for Southern Maryland (TCC), Calvert and Charles Counties in this very complex multi-state and agency air quality planning process. The current Bylaw language regarding Southern Maryland was written after intensive negotiation and discussion, with participation and approval of Maryland State officials, the Calvert and Charles Boards of County Commissioners and their respective State Senators and Delegates to the Maryland General Assembly. TCC's coordination role in the MWAQC process with our member counties has been productive and effective. They depend of our participation to provide information and objective analysis. The current Bylaws have been in place for more than ten years. We believe it would be very counter-productive and unwise to make those changes in the Bylaws.
