
- Identify strategies for effective bus lane management related to:

Task	Approach
Task 2: Information Gathering	Best practices and agency interviews on enforcement, safety, and education
Task 3: Local Application	 Application of best practices in the DC region context (legality, viability) Stakeholder meetings to identify challenges and opportunities
Task 4: Legislative Strategies	 Review of similar legislation already in place Identifying successes and challenges of these legislative actions
Task 5: Educational Campaign	 Best practices to identify effective messages for bus lane safety/enforcement Applicability of those in the DC region
Task 6: Implementation Plan	Phase process implementation planImplementation of recommendations and short term actions
Task 7: Business Case	 Order of magnitude savings as a result of enforcement (due to more efficient bus operation) Cost of enforcement (e.g., automated enforcement/police force, etc.)

Initial Findings

- Interagency coordination is essential
 - Both in the planning, design, and operational phase
- Camera enforcement was found to be effective in general
 - SFMTA observed improvements in reliability, not so much in average travel time
- Concepts that are easiest to implement are the hardest to enforce
 - "Self-enforcing" design is critical: Red paint, large overhead signs, offset lanes, contraflow lanes, etc.

Initial Findings

- No one-size-fits-all
- Implementation ("effectiveness"):
 - Working closely with agency staff and local jurisdictions
 - Bringing everyone to the table
- Higher compliance ("effectiveness"):
 - Proper signage
 - Education
 - Some police presence for enforcement

Project Overview: Challenges

- Corridors travelling through multiple jurisdictions
 - Coordination between local law enforcement
 - Consistent use of bus lane design features as much as possible (e.g., signage, color, etc.)
- Limitations in resources for active enforcement and competing priorities

Next Steps

- Complete Local agency interviews
- Work session at WMATA
 - Identify WMATA needs and expectations
 - Ways to improve continual coordination externally with local agencies and internally within WMATA
- Finalize Educational Campaign and Legislative Strategies review
- Develop framework for Implementation Plan and Benefit-Cost Analysis
