PREFACE

The U.S. Department of Homeland Security (DHS) requires that every State and Urban Area conduct an annual Multiyear Training and Exercise Planning Workshop (TEPW). As a result, the National Capital Region (NCR) Exercise and Training Operations Panel (ETOP) recently conducted a series of TEPWs and has since produced this Multiyear 2013-2014 Training and Exercise Plan (hereinafter referred to as the NCR TEP). The NCR TEP defines the Calendar Year 2013 and 2014 schedule of training and exercises across the region and the training and exercises that ETOP will lead and undertake to enhance and validate capabilities as defined in the NCR Strategic Plan.

A TEP is the foundational document guiding a successful exercise program. The TEP identifies the NCR's priorities as articulated in the NCR's Homeland Security Strategic Plan, and identifies the capabilities that are most relevant to achieving those priorities. It then outlines a multi-year schedule of training and exercises that the NCR will undertake to test, enhance, and validate its capabilities. It also graphically illustrates a multi-year schedule for training and exercise activities that support those priorities.

This Multiyear TEP is the roadmap for the NCR to accomplish the priorities described in the NCR Homeland Security Strategic Plan. The NCR has pursued a coordinated homeland security strategy that combines enhanced planning, new equipment purchases, innovative training, and realistic exercises to strengthen the Region's emergency prevention and response capabilities. Training and exercises play a crucial role in this strategy, providing the NCR with a means of attaining, practicing, validating, and improving new capabilities.

The Region's training and exercise programs are administered by the NCR Exercise and Training Operations Panel (ETOP) under the direction of the Senior Policy Group (SPG) and the Chief Administrative Officers (CAO). The ETOP is comprised of representatives from the respective NCR state and local jurisdictions. The training and exercise agenda described in this plan is binding for all Region-level response agencies, as well as any municipal response agencies receiving NCR homeland security funds. The plan helps prepare the Region to optimally address both the natural and technical hazards that it faces.

1 INTRODUCTION

1.1 PURPOSE

The NCR TEP defines the Calendar Year 2013 and 2014 proposed and scheduled training and exercises for the NCR. This document identifies training and exercise priorities and coordinates training and exercise schedules, maximizing the efficacy of training and exercise appropriations.

The NCR TEP provides a follow-on companion document to the NCR Homeland Security Strategic Plan. The NCR TEP will be updated and refined annually. The NCR TEP provides a roadmap for the Region to follow in accomplishing the 14 priorities described in the Homeland Security Strategic Plan. Each priority is further linked to the associated target capabilities that would facilitate accomplishment of the priority and the training and exercises that will help the jurisdiction obtain those capabilities and achieve that priority.

Included in the NCR TEP is the training and exercise schedule, which provides an illustration of the proposed activities scheduled for the years 2013-2014. It is representative of the natural progression of training and exercises that should take place in accordance with the building-block approach.

1.2 Process

This NCR TEP was developed through an extensive data gathering and document development process to ensure the document adequately captures and portrays the training and exercise priorities and needs of the NCR.

NCR TEP Team members worked directly with the Regional Emergency Support Functions (RESFs), Regional Planning Working Groups (RPWGs) and other NCR stakeholders to develop the NCR TEP. Furthermore, the NCR TEP Team members developed and disseminated an online survey, conducted numerous Training and Exercise Planning Workshops (TEPWs), and reviewed After Action Reports/Improvement Plans (AAR/IPs) to identify training and exercise priorities.

The NCR TEP development process was as follows:

- 1. ETOP established a 2013 2014 NCR Multi-Year Training and Exercise Planning Team comprised of representatives from Maryland, Virginia, and the District of Columbia (hereinafter referred to as the NCR TEP Team).
- 2. NCR TEP Team informed NCR Stakeholders of the NCR TEP development process.
- 3. NCR TEP Team developed a NCR TEP survey to capture training and exercise needs and priorities.
- 4. NCR TEP Team distributed the NCR TEP survey to the following NCR stakeholders: 1) NCR State representatives, 2) Exercise and Training Officers, 3) Regional Emergency Support Function (RESF) representatives, 4) Regional Planning Working Group (RPWG) representatives.

- 5. NCR TEP Team gathered data from the NCR TEP survey and included in the TEPW presentations.
- 6. NCR TEP Team conducted TEPWs with NCR stakeholders to validate information gathered from the NCR TEP surveys and provide another opportunity for NCR stakeholders to identify training and exercise priorities and needs.
- 7. NCR TEP Team developed a draft NCR TEP based on all input and disseminated draft NCR TEP to NCR stakeholders.
- 8. NCR TEP Team conducted a single, NCR-wide TEPW to discuss and refine the draft NCR TEP.
- 9. NCR TEP Team revised the draft NCR TEP based on comments received during the NCR-wide TEPW, finalized and distributed the NCR TEP.

1.3 PROGRAM PRIORITIES

Recognizing the need for a comprehensive strategic plan for homeland security in the NCR, regional stakeholders began to develop a strategic plan in 2001. A broad array of NCR stakeholder planning sessions and documents laid the groundwork for the NCR-homeland security strategic planning efforts after 9/11. In 2002, the Senior Policy Group was established to provide continuing policy and executive level focus to the Region's homeland security concerns and to ensure full integration of Regional activities with statewide efforts in Virginia, Maryland, and the District of Columbia. The Homeland Security Act of 2002 created the Office for National Capital Region Coordination within DHS, which was tasked with coordinating the domestic preparedness activities of federal, state, local, and regional agencies and the private sector in the NCR. In the Eight Commitments to Action, the Mayor of the District of Columbia and the Governors of Virginia and Maryland committed to a collaborative approach in addressing eight areas of homeland security within the NCR.

Using this groundwork, the Region worked together in a collaborative, transparent process to develop a comprehensive, specific, and achievable plan. The development of the Strategic Plan involved three major phases: consensus building (August 2004 – June 2005), Initiative development (June 2005 – November 2005) and program management and implementation (January 2006 – July 2006). It was through this process that the Region identified 14 priority areas. These same 14 priorities were reconfirmed during the 2009 TEPW through several processes including a survey of NCR jurisdictional representatives, assessment of capabilities, reexamination of the NCR's Homeland Security Strategy, and review of past After Action Reports (AARs) and Improvement Plans (IPs).

In September 2010, the NCR published an updated Strategic Plan. The goals of the 2006 Plan continue as the bedrock of the updated Strategic Plan. Regional collaboration in planning and decision-making, as well as community engagement, remain central to the NCR mission. The capabilities in the national mission areas of prevention, protection, response, and recovery are still pillars of the NCR's efforts. Like the 2006 Plan, the updated Strategic Plan recognizes the NCR's unique homeland security and preparedness challenges. Similarly, the updated Strategic Plan guides the NCR's collaborative efforts and will be continuously improved. Based on these premises, the goals have been updated to build and achieve the Region's priority capabilities

during the next three to five years. The Plan's goals identify the following key capabilities for the Region: **interoperable communications, information sharing and situational awareness, critical infrastructure protection, and development and maintenance of regional core capabilities.** The objectives and initiatives further specify the nature of these capabilities and how the Region seeks to achieve them.

2 IDENTIFIED TRAINING AND EXERCISE PRIORITIES

Through dissemination of the TEP survey and conduct of the multiple TEPWs, ETOP gathered and identified NCR training and exercise priorities. These training and exercise priorities are outlined in this section. Section 2 does not "rack and stack" or consolidate priorities for funding recommendations, it just simply lists the priorities as identified by NCR stakeholders. Section 3 of this plan "racks and stacks" or consolidates priorities by reducing redundancy, groups like activities and provides the baseline for ETOP recommended funding.

2.1 EXERCISE AND TRAINING OPERATIONS PANEL (ETOP)

2.1.1 Goal One: Ensure Interoperable Communications Capabilities

Ensure response partners have the ability to transmit and receive voice, data, and video communications

To date, the NCR and the states and localities it encompasses have dramatically invested in improving voice, data, and video communications. The Region must continue working to ensure that gaps are filled and technology is maintained and updated so that interoperable communications capabilities are improved for all response partners, including emergency managers, health, law enforcement, fire, and EMS personnel.

2.1.2 Goal Two: Enhance Information Sharing and Situational Awareness

Ensure NCR partners share the information needed to make informed and timely decisions; take appropriate actions; and communicate accurate, timely information with the public.

As demonstrated by the Derecho, Hurricane Sandy and the 2013 presidential inauguration, the NCR partners have enhanced the sharing of key tactical information, built better situational awareness, and improved the communication of key information to the public. NCR partners should have access to good, timely, tactical information from law enforcement and intelligence agencies and other relevant disciplines at the federal, state, and local level. Situational awareness allows all of these partners to work at the same time, with the same information integrated from multiple sources. With a more timely and complete picture of the situation at hand, local and state officials can better safeguard the public. Similarly, citizens depend on timely, accurate information to protect their well-being. Goal Two recognizes the importance of information sharing, situational awareness, and sharing information with the public. This goal reflects the NCR's continued commitment to further strengthen all three areas.

2.1.3 Goal Three: Enhance Critical Infrastructure Protection

Enhance the protection and resilience of critical infrastructure and key resources (CI/KR) in the NCR to reduce their vulnerability to disruption from all-hazards events.

Goal Three represents a strengthened commitment to collaborating regionally and across sectors to increase the resiliency of the critical infrastructure and key resources in the NCR. This goal includes a set of initiatives that represent a comprehensive effort to be implemented by the private and public sectors. The majority of the critical infrastructure in the Region is owned and operated by the private sector. Because critical infrastructure and key resources provide water, power, and transportation that are essential on a daily basis as well as during a crisis, the public and private sectors must work closely to ensure their security before, during, and after manmade and natural disasters.

Goal Four identifies a number of capabilities provided by the states and localities. The NCR has also invested in the enhancement of these core capabilities, resulting in a strong foundation of

preparing for, responding to, and recovering from all-hazards incidents. This goal states the NCR's commitment to ensuring that these capabilities are sustained year to year and are upgraded as needed.

4 IMPROVEMENT PLANNING AND CORRECTIVE ACTION TRACKING

The Region follows the Homeland Security Exercise and Evaluation Program (HSEEP) cycle which includes a mix and range of exercises to ensure that the Region increases its preparedness through different and progressively difficult training courses and exercise activities. Prior to conducting the TEPWs, NCR jurisdictions and regional emergency support function representatives provided the name and schedule for training courses and exercises through a data collection tool. During the TEPW, workshop participants discussed regional priorities and the listed training and exercises. Additionally, the participants identified capability gaps in priority areas and proposed additional training and exercises to close those gaps. The results of the TEPW are formalized in this TEP.

The Exercise and Training Operations Panel (ETOP) meets regularly to coordinate training and exercises. ETOP will use the TEP as the blueprint for conducting training and exercises in the NCR. Also, the ETOP will use the TEP when proposing and scheduling additional training and exercises to meet current or future priority areas. In this way, the TEP will be a living document. The TEPW materials and analyses also will help to ensure that the NCR builds on demonstrated capability and continuous improvement of corrective actions. Overall, the methodology for all training and exercise opportunities will:

Challenge participants with increasingly advanced coursework and scenarios

- Incorporate, reinforce, and verify lessons learned
- Identify demonstrated capabilities and areas in need of improvement
- Provide a means of evaluation and corrective action for exercises
- Ensure a method to share lessons learned and best practices from training courses and exercises

APPENDIX A: NCR 2013-2014 MULTIYEAR TRAINING AND EXERCISE SCHEDULE

The NCR 2013-2014 Multiyear training and exercise schedule reflects the NCR jurisdictions' planned and known training and exercise activities, as defined in their respective multiyear training and exercise plans.
