


# Washington Union Station – The Region's Hub

The multimodal hub of the Washington, DC region.

**50,000** rail passenger trips per day

**2nd** busiest railroad station in the nation



**37 million** visitors annually

#### **More visitors**

than each of the three airports serving the region.



## Union Station – An Abbreviated (!) Timeline

#### 1903

President Roosevelt signed the Act of February 28, 1903, calling for the creation of a terminal train station in Washington, DC.

#### 1981

Union Station Redevelopment Act establishes the U.S. Department of Transportation as the agency to oversee the station's restoration and transformation into a multimodal transpiration hub.

#### 1988

Union Station reopened after \$160 million restoration.

#### 1905-1908

Construction begins in 1905 on designs by Daniel H. Burnham, a leading member of the McMillan Commission Plan.

#### 1968-1969

Train travel is on the decline and Union Station is in disrepair, Congress agreed to restore the building as the National Visitor Center.

#### 1983

Union Station Redevelopment Corporation (USRC) was founded as a nonprofit organization to oversee the historic station, in fulfillment of Congressional mandate from the Redevelopment Act of 1981




Federally chartered non-profit corporation established to enter into a public/private partnership to manage Union Station

# Station Expansion Project - Overview


Completed environmental review process (NEPA EIS); FRA lead federal agency.

Considers long-term passenger and train capacity needs with projections to double capacity.

Expansion alternatives build upon the 2012 Master Plan Vision.

Includes the footprint of the historic station, terminal rail yard, parking garage and its uses (buses, parking, etc).

Includes a comprehensive Terminal Infrastructure plan for the rail terminal with consideration for rebuild of H Street Bridge.








### Status of SEP

**Significant SEP progress has been demonstrated:** The Final Environmental Impact Statement (FEIS) and Record of Decision (ROD) was released in March 2024

USRC was designated as the Project Sponsor - affirmed by USRC Board in September 2023

District government and Infrastructure DC sponsor and complete the SEP Governance Study – providing several key recommendations



SEP is currently in the Project Development Stage, as defined by FRA. A range of additional activities are required to ready the project for Final Design and Construction. This is expected to take 3 to 4 years.

# SEP Funding

Securing regional funding partnerships is critical to supplement current and future design development activities.

Completing the SEP's design development: est. > \$100 million

USRC applied for a \$30 million FSP-NEC grant in July in partnership with Amtrak – supported by DC, MD, VA.

To function as a neutral Project Sponsor, USRC needs access to additional funding sources as a direct applicant
