




Purpose: To comply with a DC Council mandate to publish:

GUN VIOLENCE PROBLEM ANALYSIS




Purpose: Identify the Key Drivers of Gun Violence



REPORTED VIOLENT CRIME, by YEAR & OFFENSE JANUARY 1, 2018 - DECEMBER 31, 2023




REPORTED PROPERTY CRIME, by YEAR & OFFENSE JANUARY 1, 2018 - DECEMBER 31, 2023




Arrests in DC

KEY TAKEAWAYS


Proportion of arrests involving juveniles increased from 24% (2018) to 34% (2023)

- Juvenile arrests steadily increased since 2020
- Adult arrests generally declined since 2018

Most common age group for arrests was 15 to 17 years old

Juvenile arrests were predominantly for robbery, including carjacking

Gun Possession Arrests in DC




KEY TAKEAWAYS

Proportion of arrests involving juveniles has consistently been about 10%

There was a steep increase in gun possession arrests from 2021 to 2022 (30%)

Most common age group for arrests was 18 to 24 years old

Factors Related to Juvenile Justice System Involvement

4.4% of all and 12.8% of highest risk youth enrolled in public school SY18-19 became involved in the justice system



Strategies to Reduce Violent Crime



PREVENTION

- Study of Childhood Risk Factors for Young Adults Convicted of Homicide
- Youth Data and Intervention Initiative: Proactively identify high-risk youth and prioritize them for intensive services and supports.
- Community Resource Hubs: One-stop-shop for community services

INTERVENTION

- **Group Violence Reduction Strategy** (aka Focused Deterrence): (1) Identify high-risk individuals; (2) Direct and respectful communication; (3) Intensive services, supports, and opportunities; and (4) Focused enforcement
- Enhance Violence Interruption Efforts: Increase number; Assign Life Coaches to all high-risk individuals; Establish violence interruption academy

COMMUNITY TRANSFORMATION

- Blight Abatement: Vacant property enforcement and "cleaning and greening"
- **Guaranteed Income Pilot**: \$750 monthly stipend to households with less than \$50K annual income and children under 10 years old

Continuum of Care for Justice-Involved Youth

 Juvenile Justice Committee will work to address the gaps in service delivery for youth involved in the juvenile justice system, including youth also in the child welfare system, and youth at-risk of system involvement.

Review of Juvenile Justice System Operations

- What's working well and what are opportunities at each stage in the system: Arrest,
 Diversion, Deferred Agreements, Prosecution, Pretrial Supervision, Probation, Commitment,
 Post-Commitment
- For youth charged with certain offenses, how do they progress through the system
