Technical Assistance Program Overview

- TPB responds to requests for technical assistance from the state and local governments and transit operating agencies
- Not a federally-mandated MPO function
- Tasks entail use of TPB-developed tools, techniques, data, and staff capabilities
- Supports DDOT, MDOT, VDOT, VDRPT, and Transit sub-area planning, travel monitoring, travel modeling, and data collection consistent with regional transportation planning priorities
- Funding is agreed-upon percentage of UPWP work program
- Technical Assistance support requests are developed through interagency collaboration and coordinated through the State Technical Working Group (STWG)



Project Eligibility



Project concepts that meet these requirements will be evaluated and recommended for inclusion in the UPWP by the State Technical Working Group.

Potential Idea – Intercity Rail and Bus Passenger Survey

- Update TPB's 2016 study "Intercity Bus Traffic and Patronage in the Metropolitan Washington Region" as to intercity bus providers, trips per day, locations, ridership
- Survey intercity bus passengers as to mode of access, origin, destination (similar to the Air Passenger survey).
- Work with Amtrak, Union Station, and agencies and jurisdictions to conduct a survey of intercity rail passengers
 - Collecting data at Union Station, New Carrolton, and in Virginia (Alexandria, Lorton, Woodbridge, Quantico, etc).
- Would require consultant assistance.



Potential Idea – Transit ZEV

- Work with transit agencies to inventory current, programmed and planned transit zero-emission vehicle (ZEV) implementation plans, including vehicles, chargers, utility needs as well as workforce development
 - "Regional Reference" on what it will take to get transit in the region to 100% ZEV (battery-electric, fuel cell)
 - Revenue vehicle needs procurement plans over next 15 years
 - Charger needs garage, on-the-street (layover points)
 - Utility connections to grid, renewable energy access, generation of own power
 - Workforce needs, non-revenue vehicles, others
