Erik Rosenfeldt, PhD Principal Investigator, Hazen and Sawyer
- Dr. Rosenfeldt will present a collaborative research project to identify and assess spatial variations in hot spots of endocrine disrupting compounds (EDCs), biological activity, and nutrients across the Potomac River Basin. Results include the efficacy of BMPs and water treatment facilities for contaminant management.
