While our region is data rich, few efforts systematically document the voices, experiences, attitudes, and perceptions of people who live here, especially across jurisdictions. Through the <u>Voices of the Community: DC, Maryland, and Virginia</u>, the Greater Washington Community Foundation, in partnership with the Urban Institute, engaged a broad cross-section of people in our region, reflecting diverse demographic characteristics, to capture a snapshot of attitudes and perceptions of daily life here. Striving to connect to our communities in new and deeper ways, this initiative helps philanthropy, non-profits, and local government understand the role they can play in enhancing and improving neighbors' experiences in their neighborhoods, in their jobs and schools, with local government, and with each other.

12:25 P.M. 4. 2018 KOGOD MILLENNIAL INDEX SNEAK PEAK

Millennials have been a driving force in the greater Washington area since the economic crisis when they sought the steady jobs and high salaries the region's strong economy provided. Now that federal spending has decreased and other major cities have fully recovered - some are even booming - Washington experienced its first net outflow of Millennials in 2016. Are Millennials still satisfied by what the Washington area offers? Have other cities become more attractive in comparison? Will Millennials stay in the region or should we expect an exodus over the coming years? The third annual Kogod Millennial Index survey and report sheds light on how Millennials feel about the region, how satisfied they are with their lives here, whether they plan to stay or move in the next five years, and what - if anything - might make them call Washington home forever. Ms. Leijon will present a sneak peak of the findings, which will be released to the public on February 1, 2018.
