The term of the TPB's 2015 Citizens Advisory Committee ends in January 2016. The term for the 2016 CAC begins in February. This memorandum presents the nominations of the member of the CAC for the 2016 term for the Board's consideration and approval.

According to the TPB's Participation Plan, the CAC comprises 15 members. Six of these members—two each from the District of Columbia, Maryland, and Virginia—are designated by the previous year's CAC. The TPB officers nominate nine individuals—three each from the District of Columbia, Maryland, and Virginia. The Participation Plan also specifies that the chairperson of the TPB will appoint the chairperson of the CAC.

In December 2015, the 2015 CAC elected six individuals to serve on the 2015 committee. Subsequently, the TPB officers reviewed the remaining applications and finalized the nominations from their respective jurisdictions. List below are all 15 nominations for the 2016 CAC.

The TPB is requested to consider the nominations and approve with or without changes, the appointment of all 15 members as well as up to three alternates for each jurisdiction. Following the Board's action, TPB Chairman Timothy Lovain will also announce the appointment of the CAC chair. The new committee will convene its first meeting on February 11.

5. Why are you interested in serving on the TPB's Citizen Advisory Committee?

Being born in Washington DC, I have watched the transformation of this community and the opportunities that continue to prevail through innovative economic development and transportation projects and initiatives. Though so much should be celebrated, I cannot help but think about the question of access for all when it comes to DC improving for the better. How do we make sure that every family has safe access to their basic health, education and job needs? How do we improve the opportunities of the city without losing the culture that has made this city so great? How do we make sure that the features that the city's transient residents enjoy can also be available to those who have lived in the city all of their lives? For almost three years as the Street Scale Campaign Manager with Safe Routes to School National Partnership I have worked within the \$30 million dollar initiative Voices for Healthy Kids in 40 undeserved communities identifying coalitions, resources, and opportunities for neighborhoods to become better for all. There are real solutions, with real people, real advocates and real elected officials that are taking advantage of the chance to address inequity issues in priority populations. Having had the privilege of bringing those experiences to the table with TPB's Citizen Advisory Committee this past year, and seeing how important the community voice is, I enthusiastically submit my application to serve.

5. Why are you interested in serving on the TPB's Citizen Advisory Committee?

As the greater Washington Metropolitan Area evolves and changes in the coming decades, the region's transportation system will need to adapt. Many members of the millennial generation, myself included, want to see transportation policies that both maintain existing road infrastructure while expanding support for mass transit alternatives. I believe that a millennial voice is needed to articulate our generation's concerns to the TPB, and believe that my background (as explained below) will allow me to offer thoughtful, nuanced contributions to the CAC's work.

6. What are your public policy and transportation interests? Please briefly describe your experiences related to those interests and how they will help you contribute to the CAC.

As a trained historian, my work focused on the development of Federal efforts to develop high speed rail in the 1960s and the impact of these efforts on subsequent federal passenger rail policy. My thesis ('Waiting for Supertrain': Trains, Technocracy, and the Great Society) argued that Federal policymakers embraced a technocratic paradigm that emphasized the development of flashy, new technologies over the application of tried and true transportation solutions. Applied in a modern context, my work demonstrates that transportation policymakers can be often swayed by the desire for "innovation" without recognizing the historic context of various operating modes.

I have also had the opportunity to work for the National Association of Railroad Passenger as an intern. This experience gave me exposure to the problems of both national long-distance and local commuter rail operations, and gave me an appreciation for the role that passenger rail can play in solving modern transportation problems. As an intern, I wrote many blogs responding to criticism of existing passenger rail projects as well as advocating for the development of new ones.

Additionally, I coauthored a paper for The Can Kicks Back's "Restoring Balance: Millennial Perspectives on America's Spending and Investment Challenges" report outlining the untapped potential of privately-financed Infrastructure Banks for various types of infrastructure investment, including transit projects. Currently, I do not participate in any organizations that would inform my involvement in CAC discussions. However, I have in the past interned for both the National Association of Railroad Passengers and The Can Kicks Back, both of which strongly champion infrastructure development.

8. Is there anything else you'd like us to know related to your interest in serve on the CAC? I believe that both my historical perspective and understanding of modern policy issues would be of great benefit to the CAC's work.

I am interested in the funding and development of critical transportation infrastructure especially public transit to support our region's growth and ensure that opportunities, especially access to opportunities, exist in every community.

Traveling and living abroad in Europe also opened my eyes to how a successful transportation network is set up. You can traverse any major European city easily without a car, and cheaply. Even in Ireland, where the bus might stop for sheep on the road, trains and buses could connect you to even the most remote of villages. I had never experienced that kind of life in my home state, New Hampshire, and have been trying to capture that lifestyle again ever since. Again, this was part of what prompted me to move to DC, and what prompts me now to support the transportation efforts of the TPB/MWCOG.
