Regional Roadway Safety Program

- Initial round
- Established and funded by the TPB via Resolution R3-2021 adopted July 2021
- Promotes TPB roadway safety priorities
- Program Funding (FY 2021)


Solicitation

- Application solicitation between January 19 March 22, 2021
 - Optional abstracts were due February 12
- 11 applications were received for \$700,000 in funding requests
 - 4 applications from Maryland jurisdictions and 7 applications from Virginia jurisdictions



Selection

- Selection Panel
 - TPB staff + safety officials from DDOT, MDOT, VDOT, and FHWA
- Individual Evaluations



 Discussion: consensus recommendations - sought balance between Maryland and Virginia



Overview of Recommendations

- Total funding: \$250,000
- 5 applications recommended for funding
 - 3 from Maryland jurisdictions and 2 from Virginia jurisdictions
 - 3 design/preliminary engineering and 2 planning
 - 4 within or connected to Equity Emphasis Areas
 - 3 involved roadway safety audits
 - 1 focused on developing guidelines



Initial Round - Projects

Initial Round - Next Steps

- July 29, 2021 COG Contracts Notified Contractors Qualified for Master Contracts
- Execute Master Contracts
- Develop SOWs
 - TPB Staff Work with Jurisdictions
- Questionnaires Sent to Qualified Contractors
 - Contractors matched to projects
 - Competitive bidding process
- Kickoff meetings (fall 2021)

New Round - Schedule

- Application period opens: August 16, 2021
- Abstracts due (optional): September 10, 2021
- Applications due: October 12, 2021
- Selection panel recommendations: October-November 2021
- TPB approves projects: November-December 2021
- Consultant selection: January February 2022
- Project kickoff meetings: Spring 2022
