MESSAGING DISCUSSED:

- 1. Speed kills utilize Inova and IIHS report findings to highlight influence of speed on pedestrian fatalities and injuries.
- 2. Increased Enforcement During and after the press conference, FCPD will heavily enforce pedestrian and vehicle traffic violations. Press will be pitched in advance of event of "ride along opportunity" with FCPD as they patrol surrounding area.
- 3. Regional Coordination/Efforts Law enforcement, proposed VA pedestrian law may still be alive, DC Ped plan, MoCo ped plan, and the DC Pedestrian Bill that raises fines to \$500 may still be alive.
