Description:

Based on new evidence of health effects from ozone at lower concentrations, EPA promulgated a new ozone standard in 2008. The new standard reduces the 8 hour standard from 85 parts per billion (ppb) to 75 ppb. The process of designating areas that do not meet the new standard, nonattainment areas, begins this year. The first step is for states to analyze monitor data in their state and recommend areas for nonattainment to EPA. The state recommendations are due to EPA Region 3 by March 12. The states will present their analysis and preliminary recommendations.

MWAQC developed the Gold Book to address innovative measures adopted by local governments to improve the region's air quality. First developed in 2003 and revised in 2006, the Gold Book addresses programs that are currently being implemented, promising initiatives that exist and are available for expansion without significant new effort, and promising initiatives that could be in pace in the future with additional effort. The Gold Book is an evolving document that is revised and updated as new ideas are conceived and demonstration programs become more widely accepted and implemented.

Staff will review measures in the Gold Book and discuss voluntary measures included in the region's State Implementation Plans (SIPs).
