Applicant Appform Codes

The following APPFORM codes must be used accordingly. Be sure to put your client App Code before the codes below. Example: If your App Code is X, you would use App Code XEMPL for an application received from an Employer Outreach survey.

- EMPL** Use this code when you receive an application from the Employer Outreach Commuter Survey.
- GRH1** The commuter is registering for GRH and **wants a match list** mailed to them. Fill in the commuter's previous mode on Page 3. Change the expiration date to one year from the day you are entering the application.
- GRH2** The commuter is **only interested in GRH**. Change the ride preferences to "neither" "neither". Change the expiration date to one year from the day you are entering the application. Fill in the commuter's previous mode.
- GRH3** The commuter is **already in the database** and is registering for GRH. Change the appcode to GRH3.
- GRH7** The commuter is registering to GRH and wants **transit information only**. Change the ride preferences to "neither" "neither". Change the expiration date to one year from the day you are entering the application. Fill in the commuter's previous mode.
- GRH8** The commuter is registering for GRH and wants **telecommuting information only**. Change the ride preferences to "neither" "neither". Change the expiration date to one year from the day you are entering the application. Fill in the commuter's previous mode.
- GRH9** The commuter is registering for GRH and wants **bicycle information only**. Change the ride preferences to "neither" "neither". Change the expiration date to one year from the day you are entering the application. Fill in the commuter's previous mode. **Enter the GRH ID number in the Travel route box.**

If a commuter is asking for a matchlist along with other information, the App code should be GRH1.

- INFO** Use this code for applications received from COG's Commuter Connections web site and the commuter is seeking information only and is not enrolled in Ridematching or GRH.
