Notice is hereby given that a public hearing will be held on Monday, May 12, 2014, at 5:45 p.m. in Room 555 at 1200 First Street NE, 5th Floor, in Washington, D.C. 20002. This hearing provides interested parties an opportunity to comment on the proposed revision to the District of Columbia's (District) State Implementation Plan (SIP), found at 40 C.F.R. Part 52 Subpart J.

The District was designated by the U.S. Environmental Protection Agency (EPA) as being in marginal nonattainment of the 2008 8-hour ozone national ambient air quality standard (NAAQS), effective on July 20, 2012 (77 Fed. Reg. 30088, May 21, 2012). To meet requirements of Clean Air Act § 172(c)(3) for marginal areas, a base year emissions inventory must be submitted to EPA as a SIP revision no later than two years after designation (42 U.S. Code § 7511a(a)(1)). Once the District has completed its procedures, the inventory and supporting documents will be submitted to EPA as a SIP revision.

Copies of the proposed SIP revision are available for public review during normal business hours at the offices of the District Department of the Environment (DDOE), 1200 First Street NE, 5th Floor, Washington, DC 20002, and on-line at http://ddoe.dc.gov/.

Notice of action: The Department of Environmental Quality (DEQ) is seeking comments and announcing a public hearing on a proposed 2011 base year inventory for precursors to the pollutant ozone, which are carbon monoxide (CO), nitrogen oxides (NO_X), and volatile organic compounds (VOC) in the Metropolitan Washington, DC-MD-VA 2008 Ozone Nonattainment Area. The Commonwealth intends to submit the inventory as a revision to the Commonwealth of Virginia State Implementation Plan (SIP) in accordance with the federal Clean Air Act. The SIP is the plan developed by the Commonwealth in order to fulfill its responsibilities under the Act to attain and maintain the ambient air quality standards promulgated by the U.S. Environmental Protection Agency (EPA).

Purpose of notice: DEQ is seeking comments on the overall 2011 inventory for the Northern Virginia portion of the Metropolitan Washington, DC-MD-VA 2008 Ozone Nonattainment Area, which consists of the counties of Arlington, Fairfax, Loudoun, and Prince William and the cities of Alexandria, Fairfax, Falls Church, Manassas, and Manassas Park.

Public comment period: March 24 to April 23, 2014.

Public hearing: A public hearing will be conducted in Conference Room 2, DEQ Northern Region Office, 13901 Crown Court, Woodbridge, Virginia, at 10:00 am on April 22, 2014. A map and directions maybe found at http://www.deq.virginia.gov/Locations/NorthernRegionalOffice.aspx.

Description of proposal: The proposed 2011 base year inventory was prepared by the Metropolitan Washington Air Quality Committee (MWAQC), which consists of elected officials from the affected localities and representatives of state transportation and air quality planning agencies.

The proposal consists of a comprehensive inventory of actual emissions from all sources of relevant pollutants for the base year 2011. This inventory, once finalized, will be the basis for any future planning exercises that have as a goal compliance with the 2008 ozone national ambient air quality standard (NAAQS).

Federal information: This notice is being given to satisfy the public participation requirements of federal regulations (40 CFR 51.102). The proposed inventory and supporting technical documents will be submitted as a revision to the Commonwealth of Virginia SIP under § 110(a) of the federal Clean Air Act in accordance with 40 CFR 51.104.

Public Comments & Responses

Public Comments

No public comments were received by the District Department of the Environment and the Virginia Department of Environmental Quality on the base year 2011 emissions inventory document. Maryland Department of the Environment received a comment letter from US EPA dated June 12, 2014. EPA sent a revised version of this comment letter dated June 27, 2014. As required by § 2.1(h) of Appendix V of 40 C.F.R. Part 51, below is a summary of the comments received and responses thereto. Included is a brief statement of the subject, the identification of the commenter, the summary of the comment and the response (analysis and action taken).

1. Subject: Use of IM240 program in Base Year 2011 onroad source emissions inventory development

Commenter: United States Environmental Protection Agency (EPA), Region III

Original Text (Comment letter dated June 12, 2014): With regards to the Onroad portion of the emissions inventory, specifically the vehicle inspection and maintenance coverage inputs for MOVES, Maryland cannot use the IM240 emissions test standards as part of the State's emissions inspection and maintenance (I/M) program. In August 2009, Maryland removed the IM240 test from the State's I/M program. This has been confirmed each year when the state submits to EPA a data analysis report for its I/M program as required by 40 CFR 51.366. As such, Maryland cannot rely on the additional emission benefits received from an emissions inspection test that is not currently implemented within the State.

Revised Text (Comment letter dated June 27, 2014): EPA withdrew its comments regarding using emissions benfits from the I/M240 program in the base year 2011 onroad mobile emission inventory. The text in the revised comment letter is as follows – "In August 2009, Maryland removed the IM240 test from the State's I/M program. This has been confirmed each year when the state submits to EPA a data analysis report for its I/M program as required by 40 CFR 51.366."

Response: Maryland has worked with EPA to fix the technical comments identified in EPA's review of the SIP with relation to the IM240 program. MDE obtained a copy of the I/M input file that generated the EPA comment from Joseph Schulingkamp at EPA and compared it with the I/M input file that was part of the draft SIP submittal. MDE's comparison determined that the two files were inconsistent and the comment wasn't accurate. MDE discussed this inconsistency with Mr. Schulingkamp on June 20, 2014 during which he verbally agreed that the I/M input file from MDE was correct and that he considered the issue resolved. MDE sent an email confirming resolution of this MOVES

I/M input issue to Mr. Schulingkamp on July 1, 2014. Subsequently, EPA sent a revised comment letter dated June 27, 2014 conforming this.

2. Subject:

Commenter: United States Environmental Protection Agency (EPA), Region III

Text (Comment letters dated June 12, 2014 & June 27, 2014): As required by 40 CFR 51.104, whenever a program is substantially revised at the state level, the state should then revise its State Implementation Plan (SIP) to reflect those changes. In general, when SIP approved emission reduction programs are revised at the state level, the state must perform an anti-backsliding analysis as required by Clean Air Act (CAA) section 110(1) and submit that demonstration as part of the SIP revision to remove or amend the relevant SIP measure. This analysis should demonstrate that the revised emission control program will not negatively impact the state's ability of attaining or maintaining the relevant NAAQS. Also, EPA's I/M requirements rule adds an additional requirement specific to I/M programs, that the revised program meet the applicable I/M program performance standard test set out in 40 CFR 51, Subpart S (using the current emissions factor mobile source model, MOVES).

Upon submittal of an I/M SIP revision by Maryland, along with the accompanying performance standard analysis and noninterfence demonstration, EPA would review the revision to ensure that the revised I/M program will continue to meet Federal requirements of both 40 CFR 51, Subpart S and the CAA.

Response: With respect to the comment regarding 40 CFR 51.104 and the revision of the IM SIP/ anti-backsliding analysis, MDE commits to working with EPA to resolve this comment/ submit any necessary SIP revisions or analysis before June 1, 2015.

Comment: The VDEQ would like to request that the following revision be incorporated:

The Virginia Department of Environmental Quality would like submit revised 2011 commuter rail emission inventory estimates for northern Virginia for incorporation into the final 2011 emission inventory to be submitted to the EPA as part of the Base Year 2011 emissions inventory (Washington DC-MD-VA 2008 Ozone NAAQS Nonattainment Area submittal). The commuter rail emission estimates for northern Virginia jurisdictions that were included in the revision of the 2011 inventory that were sent out for public review were based on an ERTAC commuter rail study that was grown to CY 2011. Since that time, VDEQ has obtained actual CY 2011 commuter rail activity data and fuel consumption data from the VRE, along with equipment specific engine emission factors and has developed CY 2011 commuter rail emission estimates for northern Virginia which we feel more accurately represent the emissions associated with this source category.
