The purpose of this memo is to propose a process for selecting stakeholder representatives to the MWAQC Technical Advisory Committee. In October MWAQC approved revised MWAQC bylaws providing that up to four governmental or nongovernmental participants ("stakeholders") may be designated as members of the Technical Advisory Committee. The bylaws state:

Up to four governmental or non-governmental participants may be designated by the TAC Chair from nominations by the Air Quality Public Advisory Committee, the Greater Washington Board of Trade and members of regulated utilities in the region.

The proposed process for selecting the four stakeholders involves three steps:

- (1) Invitation to groups from the environmental and business communities, the Air Quality Public Advisory Committee (AQPAC), the Greater Washington Board of Trade and members of regulated utilities. For each candidate, a short paragraph discussing the candidate's experience, affiliation and interest in serving will be requested. The deadline for applications to COG will be January 6, 2006.
- (2) The TAC Chair will review the applications and notify the MWAQC Executive Committee of his/her list of recommended candidates. The MWAQC Executive Committee will provide feedback to the MWAQC TAC Chair who will then make the appointments.
- (3) The MWAQC TAC Chair will be invite representatives for the four stakeholder positions to be representatives on the TAC of participation beginning with the February meeting.

Staff will send invitations to the groups named in the bylaws and other groups who have an interest in participating. Please send me the names of organizations to be invited to participate by December 16, 2005.
