

## Final Notice: Findings of Failure to Submit a Section 110 State Implementation Plan for Interstate Transport for the 2008 National Ambient Air Quality Standards for Ozone

### FACT SHEET

#### ACTION

- On June 30, 2015, the U.S. Environmental Protection Agency is finding that 24 states have failed to submit complete “good neighbor” State Implementation Plans (SIPs). These plans must demonstrate how the state will address air pollution that crosses its border and impacts other states’ ability to attain and maintain the national ambient air quality standard (NAAQS) for ozone established in 2008.
- The Clean Air Act requires states to submit good neighbor SIPs within 3 years of the EPA issuing a new or revised air quality standard. The deadline for submission of these SIPs was March 2011. These findings establish a 2-year deadline for the EPA to either approve a SIP or finalize a Federal Implementation Plan (FIP) that addresses the good neighbor requirement.
- The EPA is committed to working with these states to expedite the development and submission of their good neighbor SIPs in accordance with the requirements of the Clean Air Act.
- The list below shows the 24 states that failed to submit a complete good neighbor SIP for the 2008 ozone standards.

#### BACKGROUND

- In March 2008, the EPA revised the primary and secondary ozone standards from a level of 0.08 parts per million (ppm) to 0.075 ppm. Section 110(a) of the Clean Air Act directs each state to submit a plan known as an infrastructure SIP, that provides for the implementation, maintenance, and enforcement of revised standards, including good neighbor SIP provisions, within three years – in this case by March 12, 2011.
- The EPA acknowledges that many states may have submitted good neighbor SIPs for the 2008 ozone standards were it not for the uncertainty surrounding the Agency’s reconsideration process for the 2008 ozone standards, the EPA’s associated interim advice to states regarding implementation of those standards, and uncertainty on the statutory interpretation on the good neighbor provision because of litigation on the Cross-State Air Pollution Rule.

- In 2014, Sierra Club and WildEarth Guardians sued the EPA for failing to perform certain mandatory duties under the Clean Air Act, including a failure to find that a number of states had failed to submit good neighbor SIPs for the 2008 ozone standards.
- In a judgment entered on May 15, 2015, the U.S. District Court for the Northern District of California directed the EPA to, by June 30, 2015, make findings of failure to submit for 26 states.
- In response to the court's order, the EPA is taking this action for specified states that have failed to submit infrastructure SIPs addressing the good neighbor requirement as to the 2008 ozone NAAQS.
