

# **Regional Climate and Energy Plan**

- The Climate, Energy and Environment Policy Committee (CEEPC) lead the development of the <u>Metropolitan Washington 2030 Climate and</u> <u>Energy Action Plan</u>.
- On-road transportation emissions account for close to 1/3<sup>rd</sup> of total GHG emissions in the region; therefore, Zero Emission Vehicles is a key action area for the plan to meet our 2030 GHG emission reduction goal.

In 2022, the COG Board designated EV deployment as a regional priority.

The board recognizes the need for increased collaboration to support EV plans, programs, and policies as necessary to meet regional climate goals.

The board formed a Regional Electric Vehicle Deployment (REVD) Working Group to serve as a venue for members to cooperate and coordinate action with the approval of Resolution R40-2022.



## **Resolution Highlights**

- Establish and maintain an Electric Vehicle Deployment Clearinghouse
- A working group will be established under CEEEPC and focus on
  - Information sharing and collaborating on EV plans
  - Developing policy templates for planning, zoning, and permitting
  - Developing model partnership agreements (Site hosting, O&M, etc.)
  - Developing white papers on "deal structures"
  - Developing model incentive programs
  - Identifying and supporting opportunities to pursue regional grants
  - Prioritizing Equity Emphasis Areas



## **2023 Potential Priorities and Products**

- Increase the capacity of our members to have shovel-ready EV infrastructure projects.
- Provide and, where necessary, develop model agreements, deal structures, policy templates, and incentive programs.
- Identify and support opportunities to pursue regional funding for EV and/or EV infrastructure.
- We will also build continue to build out the EV Clearinghouse and optimize a Local Jurisdiction EV-Ready Checklist.
- EV Infrastructure Implementation Strategy.
