Full Delivery Services - Overview

- Approximately 50,000-75,000 LF of stream restoration credit in MS4 areas
- Offeror Sets Unit Price Per "Credit"
 - Credit is defined by linear feet of stream restored, inclusive of Land Acquisition, Design, Construction, Monitoring and Adaptive Management
- June 30, 2020 construction is substantially complete and easement rights conveyed to SHA

Full Delivery Services - Overview

- Single Offeror can provide multiple, independent projects
- Sites must have willing landowner
- Project may be along a spectrum of development stages – Previously Restored to New Construction
- Construction for Previously Restored projects offered must have been completed after October 21, 2010

Full Delivery Services - Overview

- Project selection based on "Best Value"
- Minimum Project Length 500LF
- MDE Stream Restoration Credit Protocol
- Project cannot have any prior credits committed
- Incremental Payment by Milestones
- Downward Payment Adjustments

- Competitive Sealed Proposals
- Single Submittal Three Volumes
 - Volume I: Statement of Qualifications
 - Volume II: Technical Proposal(s)
 - Volume III: Financial Proposal(s)

 Offerors must submit separate Technical & Financial Proposals for <u>each</u> project

RFP Overview – Volume I

- Statement of Qualifications (SOQ)
 - Offeror's Corporate Information
 - Team Experience and Qualifications Key Functions
 - References
 - Financial Capability
 - Legal Summary
 - History of Environmental Violations

Offeror will submit <u>one</u> Volume I: Statement of Qualifications

RFP Overview – Volume I

Team - Key Functions

- Project Management
- Stream Design
- Stream Construction
- Permitting & Regulatory Coordination
- Environmental Compliance & Monitoring

RFP Overview – Volume II

- Technical Proposal
- Submittals
 - Pre-Restoration Site Conditions
 - Restored Site Conditions
 - Work Plan and Schedule
 - Conceptual Plans/As-built Plans as applicable
 - All Applicable Permits/Approvals
 - Land Records, Deeds
 - Description of Landowner Concessions
 - Legally Binding Option to Purchase Easement
- Offeror will submit a complete Volume II:
 Technical Proposal for <u>each</u> project

RFP Overview – Volume III

- Financial Proposal
 - Total Project Length (in linear feet)
 - Total Project Cost
 - Unit Price Per Credit
 Credit is defined by linear feet of stream restored,
 inclusive of Land Acquisition, Design, Construction,
 Monitoring and Adaptive Management
 - Proposal Guaranty
- Offeror will submit a complete Volume III:
 Financial Proposal for <u>each</u> project
