#### 6. ADOPTION OF CONSENT AGENDA ITEMS (12:25 - 12:30PM)

#### A. RESOLUTION AUTHORIZING COG TO ESTABLISH, MAINTAIN AND MANAGE COG'S DEPOSITORY **ACCOUNTS**

The Board will be asked to adopt Resolution R9-2015 authorizing the Executive Director to establish, maintain and manage depositories for the funds of the corporation. Although Section 8.08 of COG's Bylaws specifically delegates responsibility for day-to-day management of the corporation to the Executive Director, most banking and investment institutions require confirmation that authority has been granted through a Board resolution.

#### **RECOMMENDED ACTION: Adopt Resolution R9-2015.**

#### B. RESOLUTION AUTHORIZING COG TO ESTABLISH AND MAINTAIN A TWELVE-MONTH REVOLVING **LINE OF CREDIT**

The Board will be asked to adopt Resolution R10-2015 authorizing the Executive Director to establish and maintain a twelve-month revolving line of credit of up to ten percent (10%) of total operating expenses as defined in the most recent audited financial statements. Based on the FY2014 audited financial statements, the current borrowing limit would be approximately \$4.8 million. Lines of credit are used for overdraft protection, for major expenses that must be incurred prior to reimbursement by funders, and for cash needs resulting from an emergency situation. Although Section 8.08 of COG's Bylaws specifically delegates responsibility for day-to-day management of the corporation to the Executive Director, most banking and investment institutions require confirmation that authority has been granted through a Board resolution. COG currently has an unused line of credit of \$3.0 million with SunTrust Bank.

#### **RECOMMENDED ACTION: Adopt Resolution R10-2015.**

#### C. RESOLUTION AUTHORIZING COG TO RECEIVE AND EXPEND FUNDS FROM THE U.S. DEPARTMENT OF **ENERGY'S (DOE) SOLAR MARKET PATHWAYS GRANT PROGRAM**

The Board will be asked to adopt Resolution R11-2015 authorizing the Executive Director, or his designee, to receive and expend up to \$60,000 from the DOE through a contract with Virginia Electric Power Company (Dominion) to support COG's role as a Core Advisory Team member for the development of plans and programs to foster improved markets for solar photovoltaics in the Commonwealth of Virginia. COG will provide matching funds not to exceed \$15,000 available in the Regional Environmental Budget Fund.

**RECOMMENDED ACTION: Adopt Resolution R11-2015.** 

#### D. RESOLUTION AUTHORIZING COG TO PROCURE AND ENTER INTO A CONTRACT TO PURCHASE TECHNICAL RESCUE PERSONAL PROTECTIVE EQUIPMENT FOR SIX LOCAL JURISDICTIONS AS **REQUESTED**

The Board will be asked to adopt Resolution R12-2015 authorizing the Executive Director, or his designee, to receive and expend grant funds from State Administrative Agent (SAA) for the National Capital Region in the amount of \$711,900. COG has been requested by the City of Alexandria, the District of Columbia, Loudoun County, Montgomery County, Prince George's County, and Prince William County to enter into a contract to procure Technical Rescue Personal Protective Equipment in quantities as specified. Funding for this effort will be provided through a subgrant from the SAA for the National Capital Region. No COG matching funds are required.

**RECOMMENDED ACTION: Adopt Resolution R12-2015.** 

#### E. RESOLUTION AUTHORIZING COG TO AMEND CONTRACT FOR IMPLEMENTATION OF IMPROVEMENTS TO THE ENTERPRISE RESOURCE MANAGEMENT SYSTEM (COSTPOINT)

The Board will be asked to adopt Resolution R13-2015 authorizing the Executive Director, or his designee, to amend the contract with Iuvo Systems, Inc. to the amount of \$120,000. The contract will include developing, populating and testing an improved accounting and project management system based on the results of the planning and design completed in first phase of the project. This amendment extends the contract period from three months to six months, and increases the amount of the contract to \$120,000. This is an administrative cost that will be recovered through the indirect cost rate. The resolution further authorizes the Executive Director, or his designee to amend the contract with Iuvo Systems, Inc. in an additional amount of up to \$50,000, based on a recommendation from the Chief Financial Officer or Deputy Executive Director for further testing and development after April 30, 2015.

**RECOMMENDED ACTION: Adopt Resolution R13-2015.**

#### 8. APPROVAL OF THE DRAFT ROUND 8.4 COOPERATIVE FORECASTS (12:35-12:45PM)

COG established the Cooperative Forecasting program in 1975 to enable local, regional and federal agencies to coordinate planning using common assumptions about future growth and development. The Cooperative Forecasts are developed through a "top-down / bottom-up" process which synthesizes regional econometric model projections and local government forecasts based on current and planned development. The Planning Directors Technical Advisory Committee (PDTAC) approved this fourth update to the 8th major series of Forecasts, "Round 8.4", at their January 17 meeting, reflecting the 2010 Census and local economic and demographic trends. The Board will be asked to approve the draft Round 8.4 Forecasts for use by the National Capital Region Transportation Planning Board (TPB) in the Air Quality Conformity Analysis of the 2015 Financially Constrained Long Range Transportation Plan (CLRP) and the FY2015-2020 Transportation Improvement Program (TIP).

RECOMMENDED ACTION: Adopt Resolution R15-2015, approving the draft Round 8.4 Cooperative Forecasts.

9. HUMAN SERVICES AND PUBLIC SAFETY POLICY COMMITTEE PRIORITIES AND FOCUS FOR 2015 (12:45-1:00PM)

#### COMMITTEE WORK MEMBER FEATURE OUTREACH CALENDAR MEDIA

#### NATIONAL CAPITAL REGION TRANSPORTATION PLANNING BOARD

At its January meeting, the TPB was briefed on new projects being proposed to be included in the 2015 update to the Constrained Long-Range Transportation Plan (CLRP), such as proposals to toll portions of I-66 in Virginia and expand the bike lane network in the District of Columbia. Also, as the region's administrator of a federal program to enhance transportation for seniors and individuals with disabilities, the TPB approved \$2.7 million in funding for a slate of local projects.

#### CHESAPEAKE BAY AND WATER RESOURCES POLICY COMMITTEE

CBPC received a briefing on the Conowingo Dam sediments issue by Bruce Michael, Maryland Department of Natural Resources. An expert panel also briefed the members on 2015 national and state legislative issues. Newly elected CBPC Chair, Montgomery County Councilmember Craig Rice, called for an Advocacy Workgroup to track General Assembly legislation, draft letters on national water issues, and conduct outreach. The group held their first weekly call on January 30.

#### **CLIMATE, ENERGY, AND ENVIRONMENT POLICY COMMITTEE**

CEEPC was briefed on various Smart Cities Initiatives in the region and globally, which integrate technology into infrastructure to improve decision making, as well as performance, efficiency and sustainability. COG members will have opportunities to participate in more Smart City events this coming year.

#### **REGION FORWARD COALITION**

The Coalition set regional economic competitiveness as its 2015 focus and was briefed by Dr. Stephen Fuller on the state of the region's economy. The Coalition discussed how reductions to the federal workforce and contracting activity will impact long-term regional competitiveness, and how local governments and non-profits can respond to improve the region's business climate.

#### 1. CALL TO ORDER AND PLEDGE OF ALLEGIANCE

Chairman Mendelson called the meeting to order at 12:20PM and led those present in the Pledge of Allegiance.

#### 2. ANNOUNCEMENTS

#### 3. EXECUTIVE DIRECTOR'S REPORT

Executive Director Chuck Bean updated the Board on the status of collecting the 2015 appointment letters from the 22 member jurisdictions and announced the new Board members appointed for 2015. Mr. Bean announced the open city and county manager positions throughout the region including the City of Alexandria, the City of Takoma Park, and Charles County. He highlighted the success of the COG Annual Membership Meeting and the CAO Retreat in late 2014. Last month Mr. Bean had the opportunity to tour the WMATA power plant in Prince George's County with Councilmember Karen Toles. Mr. Bean announced COG's new video podcast series that featured Rockville Mayor Bridget Newton. In conclusion Mr. Bean introduced Jennifer Schitter, the new Principle Health Planner for COG.

#### 4. AMENDMENTS TO AGENDA

There were no amendments to the agenda.

#### 5. APPROVAL OF MINUTES

The minutes of the November 12, 2014 Board Meeting were approved.

#### 6. ADOPTION OF CONSENT AGENDA ITEMS

A. RESOLUTION AUTHORIZING COG TO PROCURE AND ENTER INTO A CONTRACT TO DEVELOP A DISTRICT ALL-HAZARDS INCIDENT MANAGEMENT TEAM (IMT) CERTIFICATION-CREDENTIALING PROGRAM

The Board adopted Resolution R1-2015 authorizing the Executive Director, or his designee, to receive and expend grant funds from State Administrative Agent (SAA) for the National Capital Region in the amount of \$300,000. COG has been requested by the District of Columbia Homeland Security and Emergency Management Agency (HSEMA) to procure a contractor(s) and enter into a contract to develop a District All-Hazards Incident Management Team (IMT) Certification-Credentialing Program. Funding for this effort in the amount of \$300,000 will be provided through a subgrant from the SAA for the National Capital Region. No COG matching funds are required.

ACTION: The Board adopted Resolution R1-2015.

#### 7. APPROVAL OF FY2016 WORK PROGRAM & BUDGET

Mr. Bean will presented the proposed FY 2016 Work Program and Budget to the Board.

ACTION: The Board adopted Resolution R2-2015, approving the FY2016 Work Program and Budget.

#### 8. ADOPTION OF 2015 LEGISLATIVE PRIORITIES

Vice Chair Berliner explained the process of the legislative priorities and 2015 Legislative Committee. Ms. Beyrouti presented the four proposed 2015 Legislative Priorities to the Board for review.

ACTION: The Board adopted Resolution R3-2015, approving the 2015 Legislative Priorities.

#### 9. MARKETPLACE FAIRNESS ACT LEGISLATIVE DISCUSSION

Ms. Beyrouti briefed the Board on the proposed Marketplace Fairness Act legislation. The proposed bill would allow states and local governments to require online and other out-of-state retailers to collect sales and use tax.

ACTION: The Board received the briefing and directed staff to prepare a letter on behalf of the Board in support of the Marketplace Fairness Act.

#### 10. 2015 STATE OF THE REGION INFRASTRUCTURE REPORT

Mr. Freudberg and Ms. Beyrouti presented the 2015 State of the Region Infrastructure Report. The report was a culmination to the 2014 Board focus on Infrastructure. The report focused on transportation, water, energy, public buildings, and public safety infrastructure and provides an overview of the current conditions and funding gaps that need to be addressed. Chairman Mendelson led a discussion and took comments from the Board.

ACTION: The Board adopted Resolution R4-2015, accepting the 2015 State of the Region Infrastructure Report.

#### 11. ELECTION OF 2015 COG BOARD OFFICERS

Chairman Mendelson recommended approval of the 2015 proposed slate of COG Board officers: Chairman William Euille, Vice Chairman Roger Berliner, and Vice Chairman Kenyan McDuffie and requested that a copy of the memos regarding the 2016 nominating committee be included in the minutes.

ACTION: Adopt Resolution R5-2015, electing the 2015 COG Board Officers.

#### 12. RECOGNITION OF IMMEDIATE PAST CHAIRMAN (1:35-1:40PM)

Chairman Euille recognized Council Chairman Phil Mendelson and thanked him for his service as COG Board Chair in 2014.

By motion, the Board of Directors temporarily concluded the public meeting and convened in Executive Session for the purpose of discussing the results of the Executive Director's performance evaluation as conducted by the Employee Compensation and Benefits Review Committee (ECBR) and other COG Board Members.

ACTION: Subsequent to the Executive Session, the Board adopted Resolution R7-2015, approving the recommendations of the ECBR.

#### **15. OTHER BUSINESS**

Vice Chair Berliner made a motion to direct COG Executive Director Bean to work with the appropriate entities and staff to arrange a presentation to the Board by WMATA regarding its current protocols in the event of an emergency situation in the Metro system, and for the Emergency Preparedness Council, in due course, to examine this issue.

ACTION: The Board adopted Resolution R8-2015, approving the motion to direct the arrangement of a WMATA presentation to the Board.

(Note: this decision was developed in late 2012 within the Nominating Committee for 2013 and the election was approved by the Board in January 2013.)

- Maryland held the chairmanship *twice* in a three-year period (i.e., in 2011 [Harrison] and then again in 2013 [Young]).
- However, the District had its chairmanship *postponed* for a year with the understanding that the District and Maryland would "swap back" as Chairman Mendelson shared with his Executive Committee colleagues at their organizing meeting in early 2014.
- Note: The Virginia chairmanship remained steady in the three-year rotation (i.e., 2012 and 2015).

#### Consensus

A consensus emerged within the 2015 Nominating Committee to enact the "swap back" in 2017, thus preserving the rotation of the (presumptive) 2105 Executive Committee consisting of Euille, Berliner, and McDuffie.

This consensus also addressed a concern that this convention be adequately memorialized for the benefit of successive nominating committees in 2016 and 2017. Thus, I am instructing Monica Beyrouti, the COG Clerk to the Board of Directors, to share this memo with successive nominating committees and their presumptive chairs Euille and Berliner, respectively.

Thus, it is understood and memorialized that:

- The 2017 Nominating Committee (presumptively, to be chaired by Roger Berliner in late 2016) will nominate a Chair from the District of Columbia to serve in 2017.
- And, this Committee will nominate a Maryland Vice Chair with the understanding that he/she will serve as a Vice Chair for 3 years before potentially assuming the role of Chair in 2020.

Please respect the well-established rights of states and local governments to govern in the best interests of their voters and consituents, and continue to foster the federal-state-local partnership that is essential for state and local elected leaders to fulfull their responsibilities to provide essential public services.

The COG Board of Directors urges you to consider the influential role implementing the Marketplace Fairness Act could make in local communities throughout the country and support passage of the bill in 2015. WHEREAS, the Cooperative Forecasting Program has involved the active participation of the Council's participating governments, as well as Anne Arundel, Carroll and Howard counties and the Tri-County Council for Southern Maryland, which have provided local population, household, and employment forecasts, documentation of methodology and assumptions upon which the forecasts are based, and related analyses for use in the process, and has involved full participation of the Baltimore Metropolitan Council, Fredericksburg Area Metropolitan Planning Organization, the Maryland Office of Planning, and the National Capital Planning Commission; and

WHEREAS, to further enhance coordination between regional land use and transportation planning, on February 12, 2003 COG adopted Resolution R8-03, which recommends that approval of each round of the Cooperative Forecasts should occur concurrently with the completion of the National Capital Region Transportation Planning Board's (TPB) Air Quality Conformity Analysis of the Transportation Improvement Program (TIP) and the Financially-Constrained Long Range Plan (CLRP); and

**WHEREAS,** on January 16, 2015 the Planning Directors Technical Advisory Committee recommended approval of the fourth update to the 8<sup>th</sup> major series of Cooperative Forecasts –"Round 8.4" - for use by the staff of the TPB in the year Air Quality Conformity Analysis of the 2015 Financially Constrained Long-Range Plan (CLRP) and the FY 2015-2020 Transportation Improvement Program (TIP).

#### NOW, THEREFORE, BE IT RESOLVED BY THE COG BOARD OF DIRECTORS THAT:

- 1. The Board approves the Round 8.4 Forecasts attached as part of this Resolution and commends the Planning Directors and its Forecasting Subcommittee for their work to develop the projections.
- 2. The Board charges the Region Forward Coalition and the Planning Directors Technical Advisory Committee with monitoring the Round 8.4 Cooperative Forecasts to identify any potential changes in assumptions about land use, transportation and the region's economy and modify the Round 8.4 Cooperative Forecasts as necessary.

## NATIONAL TRANSPORTATION SAFETY BOARD (NTSB) BRIEFING ON THE INVESTIGATIVE PROCESS FOLLOWING TRANSPORTATION ACCIDENTS



#### Preliminary Report Railroad DCA15FR004

The information in this report is preliminary and will be supplemented or corrected during the course of the investigation.

On January 12, 2015, about 3:15 p.m. eastern standard time, Washington Metropolitan Area Transit Authority (WMATA) Metrorail train 302 stopped after encountering an accumulation of heavy smoke while traveling southbound in a tunnel between the L'Enfant Plaza Station and the Potomac River Bridge. After stopping, the rear car of the train was about 386 feet from the south end of the L'Enfant Plaza Station platform.

A following train, stopped at the L'Enfant Plaza Station at about 3:25 p.m., and was also affected by the heavy smoke. This train stopped about 100 feet short of the south end of the platform. Passengers of both trains, as well as passengers on the station platforms, were exposed to the heavy smoke.

Both Metrorail trains involved in this incident consisted of six passenger cars and were about 450 feet in length. As a result of the smoke, 86 passengers were transported to local medical facilities for treatment. There was one passenger fatality and two passengers were hospitalized in critical condition.

NTSB investigators have inspected the area of the incident, where they observed severe electrical arcing damage to the third rail and electrical cables about 1,100 feet ahead of train 302. Recorded data shows that at about 3:06 p.m., an electrical breaker at one end of a section of third rail tripped (opened). At about 3:16 p.m. the WMATA Operations Control Center (OCC) began activating ventilation fans in an effort to exhaust smoke from the area. The electrical breaker at the other end of the third rail section remained closed; supplying power until the WMATA OCC remotely sent a command to open the breaker at about 3:50 p.m.


NTSB investigators are reviewing maintenance records of track, signal and power inspections, and railcar vehicles; documentation on previous events with smoke generation; maintenance and repair records of the tunnel exhaust fan/ventilation operations; WMATA emergency response and evacuation plans; and employee training records. Investigators have also collected material samples from the incident site and are examining the samples at the NTSB Materials Lab. In addition, NTSB investigators are currently conducting interviews with personnel involved, and have begun the collection and review of all available surveillance video.

The NTSB has formed the following technical investigative working groups:

- Operations
- Survival Factors
- Fire Science
- Signal and Power
- Track
- Civil Engineering/Infrastructure
- Mechanical/Equipment
- Recorders

The NTSB Transportation Disaster Assistance Division is providing support to the WMATA victim assistance team.

Parties to the investigation include: the Federal Transit Administration, Tri-State Oversight Committee, Washington Metropolitan Area Transit Authority, Amalgamated Transit Union Local 689, and the Bureau of Alcohol, Tobacco, Firearms and Explosives.

### A Letter to Our Riders

We apologize to all Metro riders, and particularly to the family of Carol Glover and those injured or impacted by the events of Monday afternoon. We also want to thank those first responders and passengers who came to the aid of our riders. The incident that occurred on the Yellow Line outside L'Enfant Plaza was harrowing for the passengers aboard that smoke-filled train, and caused a major service disruption for thousands of others. We know that we have to redouble our efforts to learn from this and take every step necessary to make sure it doesn't happen again.

You have our absolute commitment that we will provide a full accounting of what happened on that day, from the cause of the smoke to our emergency response. Even before the National Transportation Safety Board (NTSB) completes its investigation, we will take immediate action to address any interim recommendations.

Metro has committed its full resources and is actively participating in the NTSB investigation. Recognizing that our riders depend upon the region's emergency responders, we have been steadfast in participating in drills with other agencies and we are working with the Metropolitan Washington Council of Governments to review our interagency protocols and determine opportunities for mutual improvement. We will continue to keep the public informed of the steps we are taking.

Our safety work is not complete; it will never be. For the past four years, Metro has worked every day to improve safety and reliability. We are half-way through a rigorous capital improvement program to upgrade equipment and infrastructure. We have trained thousands of employees in rail safety. And while we modernized our passenger information and incident command programs, safety requires constant vigilance.

Your safety, and your trust in Metro to deliver safe and reliable service, is paramount to us.

Dear Mr. Downey and Mayor Euille,

Leaders of the Washington Metropolitan Area Transit Authority (WMATA) and the National Transportation Safety Board (NTSB) briefed members of the Virginia, Maryland and District of Columbia congressional delegations on Wednesday to provide preliminary information on the fatal Jan. 12, 2015 smoke incident at Metro's L'Enfant Plaza station. We discussed the current status of the NTSB's investigation into the incident, as well as broader current efforts to make safety improvements to the Metro system serving hundreds of thousands of daily commuters and visitors to the national capital region. Although we received answers to some of our questions, many other questions have been left unanswered.

One area of particular concern to me was the breakdown in radio communications among first responders as they attempted to reach the stationary train car to rescue stranded passengers. It is apparent that the process WMATA and its partners currently employs to address communication problems needs greater oversight and urgency. According to officials participating in Wednesday's briefing, WMATA was alerted to problems with radio communications at L'Enfant Plaza by D.C. Fire and Emergency Medical Services on January 8th. Although there are reports which suggest Metro employees began looking into the problems over the weekend of Jan.11-12, WMATA apparently did not schedule a time to collaboratively address the issue with D.C. fire officials until January 14 -- nearly one week later. Tragically, as we all know, the fatal accident occurred in this intervening period.

Radio communication for first responders in any emergency is of vital importance. I strongly urge WMATA to work more closely with its local partners, and in a more transparent and robust way, to correct specific interoperability issues in a much more timely and responsible way. Metro's riders deserve better than to rely on a transit system in which emergency communications equipment is known to be inadequate or ineffective, yet no sense of urgency is demonstrated to fix the problems.

I know that local public safety networks and radio systems operate independently. I would strongly suggest that WMATA, in conjunction with COG, develop a process in which each jurisdiction notifies its partners and tests equipment whenever updates or other significant changes are made. Because WMATA owns and maintains much of the infrastructure through which those systems operate during emergency events, it is imperative that WMATA proactively

engage its local emergency response partners on a regular and sustained basis to ensure that all of its communications infrastructure and equipment is properly up-to-date and functioning appropriately. Passenger safety on the nation's second largest transit system requires no less.

Yesterday, we were assured that WMATA has corrected the specific communication problem that existed at L'Enfant Plaza on Jan. 12. However, I would request some assurances that WMATA has proactively tested the entire system – in close coordination with local first response agencies – to ensure the interoperability and integrity of the entire network over the entire Metro system. I further understand that COG already is actively engaged in assessing the effectiveness of cellular telephone capacity across the Metro system. I would suggest that COG and WMATA further partner to design and implement this project to ensure emergency response interoperability and communications infrastructure across the entire system, and ensure that it is maintained going forward. I would appreciate a status update, or at least a credible work plan, no later than Jan. 30<sup>th</sup>.

Since the 9/11 attacks more than thirteen years ago, our nation has invested hundreds of millions of dollars to improve emergency communications and provide reliable and secure interoperable public safety networks. Progress should not be undone, and more lives should not be put at risk, because we have failed to maintain and update our emergency communication infrastructure.

#### Dear Senator Warner:

We write to jointly respond to your letter of January 22, 2015, asking for a work plan to enhance effective emergency communications across the Metro system. We share your resolve that the Metro transit experience be as safe as possible, and want to assure you that we are working together to establish formal protocols and procedures for radio testing that will be incorporated into an agreement between the regional emergency responders and WMATA. In addition to the testing that already takes place, following the incident at L'Enfant Plaza on January 12<sup>th</sup>, WMATA and jurisdictions with Metrorail stations report that they have tested the radio communications. We are working systemically to address any issues that were found during the testing in order to assure that radio communication within the Metrorail system is in good working order. In addition, we are working together to identify any other areas where improvements can be made in emergency communications and incorporate them into the agreement. Our goal is to proactively build upon the work done to date.

#### Background on Current Metro Transit - Fire/Rescue Emergency Procedures Policy Agreement

Before explaining the particulars of our work plan, we want to provide background on the existing agreement between WMATA and the regional emergency responders. Protocols for emergency response in the Metro system are formalized in an agreement, coordinated through the Metropolitan Washington Council of Governments (COG), which is signed by WMATA and every fire chief in the region: the "Metro Rail Transit - Fire/Rescue Emergency Procedures Policy Agreement 2011." ("Policy Procedures Agreement")

The Procedures Policy Agreement details roles and responsibilities around incident command, with the National Incident Management System (NIMS) serving as the foundation of that agreement. Under NIMS, during an emergency when the Fire Department is called in, the Fire Department assumes full control of the emergency upon arrival on the scene and is responsible for coordinating all activities at the scene, including all actions taken by Metro. Specifically, the battalion chief or other senior fire official is designated as the Incident Commander. This unified command structure is used to coordinate and control activities at the scene. The Incident Commander establishes a command post where face-to-face coordination takes place, and then messages are sent out to the respective teams.

Radio communication takes place through two separate radio systems operating in the Metrorail system – the radio system that Metro uses and the radio system that the local jurisdictions use. Metro is responsible for assuring that it maintains a robust and redundant capability to link with its regional radio partners.

With nearly 5,000 Metro employees using radios – including train operators, station managers and Metro Transit Police Department officers - Metro is responsible for constantly troubleshooting and testing the system. Whenever an issue is detected, a work order is placed through Metro's Maintenance Operations Center and the radio connection is restored quickly.

The jurisdictions are responsible for and regularly conduct their own testing which includes the radio connections through Metro's bi-directional amplifier. WMATA and COG are committed to creating a regionally coordinated schedule for testing, reporting and resolving issues that are identified. This is one of the key issues that we expect that the revised Policy Procedures Agreement will address.

To build upon these protocols, COG will serve as a forum and a convener to address issues affecting the National Capital Region jurisdictions, and help foster cooperation and coordination between WMATA and the region's emergency first responders. COG will convene the appropriate committees, and assist in facilitating needed outcomes.

#### Proposed Work Plan

Attached is the work plan which we will use as a focus of our joint efforts. The policy and procedures of the work plan will be developed by the region's emergency first responders with the assistance of appropriate subject matter experts. The COG Fire Chiefs Committee will oversee and facilitate the work plan. The current effort of updating the "Metro Rail Transit -Fire/Rescue Emergency Procedures Policy Agreement 2011" will be expanded to address collaborative testing of radio communications by WMATA and emergency responders, assessing the effectiveness of cell phone communication across the Metro system, and ongoing protocols for emergency communications. A third party or other means of certification will be identified for the assurance part of this work plan.

Because of the broad implications of transit communications, COG's Fire/Rescue Passenger Rail Subcommittee of the Fire Chiefs Committee will solicit input from representatives from other disciplines or refer specific issues to other relevant COG Committees, such as the COG 9-1-1 Committee and the COG Public Safety Communications Subcommittee. Funding implications will be considered. The work plan contains immediate and long term phases.

We are prepared to develop an amendment to the existing Procedures Policy Agreement between WMATA and the regional emergency first responders. The revised Agreement will formalize commitments to ongoing protocols and a long term operational plan for insuring radio communication and related issues.

We will begin this work with the next monthly meeting in February of the COG Fire Chiefs Committee. Work plan activities will be meshed with the various other ongoing actions that relate to WMATA and emergency response.

In addition, the COG Board of Directors will meet on February 11<sup>th</sup> at which time WMATA will provide a briefing on Emergency Response protocols, including radio communications. WMATA and COG both recognize the critically important role effective emergency communications play in the safety of Metrorail riders.

#### REGIONAL WORK PLAN FOR ENHANCING FIRST RESPONDER COMMUNICATIONS SYSTEMS IN THE **METRO SYSTEM**

Purpose: The purpose of this Regional Work Plan is to establish a system to ensure that WMATA and first emergency responders test communications systems at each Metro stations and all rail tunnels to make certain that the communications systems are continuously operational. The work plan contains immediate and long term phases.

Process: The COG Fire Chiefs Committee will oversee and facilitate the work plan. The details of the work plan will be provided by the region's emergency first responders with the assistance of appropriate subject matter experts. Because of the broad implications of transit communications, the COG Fire/Rescue Passenger Rail Subcommittee of the Fire Chiefs Committee will solicit input from representatives from other disciplines, such as the COG 9-1-1 Committee and the COG Public Safety Communications Subcommittee.

Short Term Actions: Testing of all Metro stations and tunnels and agreement by WMATA and the region's Fire/Rescue Chiefs for ongoing testing.

#### Deliverables:

- 1) Documentation of test results of Metro stations and all rail tunnels WMATA and jurisdiction testing.
- 2) Agreement by WMATA and Fire/Rescue Chiefs to protocols for ongoing testing, reporting and correction of deficiencies, to include timing and frequency.

#### Deadline:

- 1) Documentation report on testing: 30 days to WMATA General Manager and COG Executive Director.
- 2) Initial agreement on testing protocols between WMATA and jurisdictions: 60 days

#### **Phase Two Actions:**

- 1) Development of an amendment to the "Metro Rail Transit Fire/Rescue Emergency Procedures Policy Agreement 2011" ("Procedures Policy Agreement") to formalize commitments to ongoing protocols and a long term operational plan for insuring radio communication and related issues. A third party or other means of certification will be identified for the "assurance" part of this work plan.
- 2) Funding implications will be considered.

#### Deliverables:

- 1) Agreement by WMATA and Fire Rescue/Chiefs to revision to Policy Procedures Agreement.
- 2) Funding recommendations.

Deadline: Proposed agreement within 120 days to the WMATA and COG Boards of Directors.
