Item 4: Air Quality Plan (SIP) Status

### **Description:**

Ms. Rohlfs will discuss development of the 8-hour ozone air quality plan (SIP). Due to coordination of modeling between Virginia Dept. of Environmental Quality with other modeling centers in the Ozone Transport Region, there continue to be delays in attainment modeling for the Washington region. Final attainment modeling results are expected in mid-November. The modeling results will be included in the draft air quality plan that will be submitted to MWAQC for approval for public hearing in January. Public hearings will be held in March and final approval of the SIP is expected in April.

Ms. Rohlfs will discuss the MWAQC schedule for the next six months.

Item 6. MWAQC Comment on Conformity Analysis

# **Description:**

In September the Transportation Planning Board (TPB) Technical Committee released a draft conformity determination for the 2006 CLRP and 2007-2012 TIP. Results indicate that the TPB will be able to demonstrate conformity for both the 8-hour and  $PM_{2.5}$  requirement. The MWAQC Executive Committee approved a comment letter recommended by the Technical Advisory Committee and the letter was sent to TPB before the October 18 comment deadline.

Mr. King will review the comment letter and the expectations for future mobile budgets to be used in transportation conformity analyses.
