
## Federal Requirements for MPOs Benefits of MPOs

- Serves as a representative group of local stakeholders of the region
- Carries out the "3C Process" "Continuing, cooperative, and comprehensive" consultation process
- Leads the REGIONAL transportation planning process in cooperation with the state DOT(s) and transit operators
- Develops plans and programs that consider all transportation modes and support metropolitan community and economic development
- Works in conjunction with state air and transportation agencies to meet federal Clean Air Act standards



#### **About the TPB**

- Federally designated MPO for the Washington region
- 44 members, including federal, state and local agencies and 24 jurisdictions
- 3,500 square miles in area
- More than 5 million people and nearly 3 million jobs
- About 17 million person trips per day





### **About the TPB (continued)**

- Serves as the regional forum to discuss and develop consensus
- Prepares plans and programs that the federal government must approve in order for federal-aid transportation funds to flow to metropolitan Washington
- Provides technical resources for decision-making





### Unified Planning Work Program – "How" the work is done

- A Unified Planning Work Program (UPWP) is an annual statement of work identifying the planning priorities and activities to be carried out within a metropolitan planning area
- MPOs are required to develop UPWPs to govern work programs for the expenditure of FHWA and FTA planning funds [23 CFR 450.308)(b)]
- Board to approve March 18, 2020
- FHWA and FTA to approve by June 30, 2020

#### **UPWP** Revenues

- FHWA PL and FTA Section 5303 (80% federal; 10% state DOT; 10% local COG dues)
- The total FY 2021 revenue comes from 3 "buckets" of funding through the state DOTs:
  - "New" fiscal year funding (Federal FY 2020)
  - "Old" funding from last year's UPWP (FY 2019) obligated to the MPO but not spent (called "unexpended")
  - "Carryover" funding from current year UPWP (FY 2020) that we anticipate not being able to spend by June 30, 2020
- Preliminary revenues: \$18.2 million
- Preliminary expenditures: \$18.2 million




