Background

- MOITS Technical Subcommittee Chair Amy Tang McElwain suggested reviving previous years' efforts to create a regional MOITS strategic plan
- Such a plan was drafted in 2001 but never finalized
- MOITS recently looked at the outline for the 2001 plan
- In a related effort, staff undertook a survey of MOITS participants

Recommendations – Structure and Content

- Keep the focus on only those limited number of topics that are truly regional and interagency in nature
- Have enough specificity for clear agreement, but not to the level of interfering with individual agency/ jurisdictional prerogatives
- Associate the strategic plan with the regional ITS architecture, but do not make the strategic plan a technically detailed document
- Keep similar outline to 2001, with some ability to clarify structure and content

Recommendations – Steps and Time Line

- Identify what topic areas should be included (update from 2001)
- Identify resources needed
- Once topics are identified, do a <u>strategic</u> MOITS inventory for the region
- Use in-house COG/TPB staff
- Overview document by September 30
- Conduct Inventory October/November
- Finalize strategic plan (including input from inventory) by December 31

Market Packages

- Return to the recommendation to build from the National and Regional ITS Architectures
 - Sets a common framework for topic areas and nomenclature
 - Already has indicators of current and future directions
 - Can emphasize or supplement topic areas as needed
- Use the National ITS Architecture "Market Packages" (Atlanta approach) to initiate the strategic planning effort
- Relevance of Market Packages to MOITS will vary; many can be de-selected
