The TPB is required to conduct an Environmental Justice analysis examining the constrained element of Visualize 2045 for impacts on low-income populations, minority populations, or both. Using the TPB-approved Equity Emphasis Areas, staff will present the results of this analysis. It demonstrates that Visualize 2045 does not have a disproportionately high or significantly adverse impact on these population groups.
