The City of Frederick has developed a Climate Action Plan (CEP) for City operations to address current and future climate change. The CAP comprehensively considers the changing climate in the City by addressing both mitigation and adaptation. This scope is focused on City government operations and includes buildings and facilities the City owns and operates, streetlights, and traffic signals, water and wastewater treatment plans, fleet vehicles, and nonfleet vehicles and equipment (e.g., lawn mowers, constructions equipment).
