1. REVIEW AND APPROVAL OF A JOINT LETTER FROM TPB, MWAQC, AND CEEPC TO THE NATIONAL HIGHWAY SAFETY ADMINISTRATION ON A PROPOSAL TO REVISE FUEL ECONOMY/EFFICIENCY STANDARDS

In an August 17, 2023 Federal Register notice, the National Highway Safety Administration (NHTSA) is seeking comment on a proposal to revise Corporate Average Fuel Economy Standards for Passenger Cars and Light Trucks for Model Years 2027-2032 and Fuel Efficiency Standards for Heavy-Duty Pickup Trucks and Vans for Model Years 2030–2035, due October 16. A joint letter from the Transportation Planning Board (TPB), the Metropolitan Washington Air Quality Committee (MWAQC), and the Climate, Energy and Environment Policy Committee (CEEPC) supporting the proposal has been drafted for review and approval. The Steering Committee will be asked to approve this letter.

Action: Approve draft letter for the TPB Chair's signature.

2. REVIEW AND APPROVAL OF AN AMENDMENT TO THE FY 2024 COMMUTER CONNECTIONS WORK PROGRAM (CCWP) TO INCLUDE FUNDING TO EXPAND THE EMPLOYER OUTREACH PROGRAM STATEWIDE IN MARYLAND

MDOT will be contributing an additional \$40,000 in state funding to the CCWP in order to expand Commuter Connections' Employer Outreach Program beyond the TPB planning area to cover the entire state of Maryland. TPB staff have determined that since this program is not considered "regionally significant" in terms of the air quality conformity requirement and the additional funding is not federal, that a similar amendment to the FY 2023-2026 TIP is not required.

  which adds funding for a new study for an Area of Persistent Poverty and for
  capital investment in 20 new zero-emission electric buses and supporting
  infrastructure in Prince George's County, as requested by MDOT.
- Adopt TPB Resolution SR5-2024 to amend the TIP to include TIP Action 23-23.3
  which adds funding for two new roadway project records and two new transit
  program records, and updates funding programmed on one roadway project
  record and one transit project record, as requested by VDOT,
