Mr. Evans will discuss the update process for the Maryland Bicycle and Pedestrian Plan, including MDOT's transition to using level of traffic stress (LTS) for measuring bicycle mobility.

As part of this process MDOT has developed an active bike inventory in <u>SHA's One Maryland One Centerline (OMOC)</u> linear referencing system. This web-based application allows contributors to add where new bike facilities have been created, thus helping maintain the basis for LTS scores.

Trails Network.

This project will fund the rehabilitation and construction of <u>six multi-use paths</u> to fill gaps in the bicycle and pedestrian network in the Washington, DC metropolitan area. The multi-use path improvements include approximately seven miles of new construction, approximately eight miles of trail rehabilitation, and safety improvements at intersections and at-grade crossings.

Separately, DDOT was able to obtain a RAISE grant for a one-mile shared use path along Wheeler Road SE, which connects to the Capital Trails Network (and NCTN).
