RE: Public Comments Received on the Draft Air Quality Conformity  
Determination for the 2004 Constrained Long Range Plan (CLRP) and  
the FY 2005-2010 Transportation Improvement Program (TIP)

On October 1, the Conformity Determination, the 2004 CLRP and the FY 2005-2010 TIP were released for public comment. The public was encouraged to submit comments online using the attached form. To date, TPB staff has received over 300 comments. The majority of the remarks have been focused on the Intercounty Connector (ICC) in Maryland. Persons making comments are asked to categorize their remarks for tabulation. Approximately half of the comments received so far are in support of the proposed 2004 CLRP update including the Intercounty Connector while the other half are in opposition.

The public comment period closes on October 31. Responses to all comments received through the 31<sup>st</sup> will be provided for the November 17 TPB meeting.
