

### **Future Meeting Topic Suggestions**

- Green house gas inventories
  - Feasibility of COG providing all members inventories
  - Inventory updates to include new federal fuel efficiency programs and other recent initiatives
- Energy
  - Total impact of GSA facilities in the region and impact of mandated energy conservation goals, telework, and current activities over next 10-20 yrs
  - Trends in building energy codes and municipal programs carrot or stick?
  - Sewer waste hear recovery (Vancouver as example)
- Land use
  - How local land use policies and plans address climate and energy issues and what localities can do differently
  - Issues in adaptation (speaker from Georgetown Climate Center)
  - Tree planting, health and improving tree canopy
- Utilities
  - Achieving environmental and energy efficiency goals by working with utilities
  - Panel of utility commission staff from MD, DC, and VA to discuss how projects are approved, considered for cost recovery and regulatory framework (regulated vs. de-regulated) impacts
- Economic
  - Environmental and energy initiatives as means of promoting economic development
  - Analysis of programs and their true net worth (solar, alternative fuel production, etc)
- Transportation and climate adaptation
- Health and climate change
- Water conservation



### **Suggestions to Improve Meetings**

#### Focus

- CEEPC Workplan tie topics and presentations directly to workplan. Could focus on a couple plan elements at each meeting and discuss progress, challenges and how to address challenges.
- Translate presentations into actions. Provide opportunity for strategic conversation on how to effectuate change in local policy, budget allocations, etc
- Policy level focus; less on administrative or technical matters and details that can leave nonexperts a bit confused
- January meeting outstanding representation of how meetings should continue
