SNAP in the COG Region

- 41% increase in individual participation, 42% increase in household participation between January 2020 and January 2021
 - February data indicates continued growth in enrollment
 - Emergency allotments and a 15% increase to benefit levels in effect
- Meeting recertification requirements for SNAP participants is critical to maintain benefits

SNAP in the COG Region

- In Virginia, most qualifying applicants must have a gross income within 130% of the FPL and meet an asset test.
 - On July 1, VA will remove the asset test and increase the gross income test to 200% of the Federal Poverty Line (HB 1820)
 - More households will qualify for SNAP

For a three-person household in FY21, the gross monthly income limit to be eligible for SNAP at 130% of the poverty level is \$2,353.

Food Insecurity in the COG Region

- Reach out to local social service departments and organizations like DC, MD, and VA Hunger Solutions to learn more about SNAP in our communities
- Data from the U.S. Census Household Pulse Survey from July 2020 to March 2021 for Washington MSA indicates:
 - Households with children report higher rates of food insufficiency (very low food security)
 - There are disproportionate impacts to Hispanic or Latino and Black individuals and households
- Updated Hunger Report from Capital Area Food Bank expected later this spring
