# Statewide Multimodal Freight Study Follow up

### **Track Project Status**

/DOT

- Near term projects
- Potential longer term projects

#### Address recommendations from the Phase 2 Study report

- Propose a process for the Multimodal Advisory Committee
- Re-convene the freight sub-committee
- Present ITS component to VDOT Chief of Operations and select group


# Statewide Multimodal Freight Study Follow up

Near term projects (Statewide)

- ~33 projects in the "Plan"
- 3 completed

VDOT

- 13 with scheduled construction: completion dates range from overdue to 2022 (HR 3<sup>rd</sup> Crossing)
- 13% complete (by expenditures)
- 8 projects not in the Program

**Potential longer term projects (In progress)** 

- 2035 Long Range Plan
- 45 Projects

- Scope: Data and information collection; Summary, maps, and gap report.
- Status: completing data collection and draft report.
