## **RESOLUTION TO SUPPORT THE PARTNERSHIP WITH THE ALICE FERGUSON** FOUNDATION TO PURSUE THE GOAL OF A TRASH-FREE POTOMAC RIVER BY 2013

**WHEREAS**, the Potomac River and its many tributaries are a vital recreational resource for the region and a key contributor to the region's quality of life; and

**WHEREAS,** this resource is severely degraded by the many forms of trash that float on the surface and collect on the shorelines of these rivers and streams; and

**WHEREAS,** the Alice Ferguson Foundation (Foundation) has taken a leadership role in by sponsoring watershed cleanups throughout the Potomac watershed for 17 years; and

**WHEREAS**, the Foundation sponsored the signing of the "Potomac River Watershed Trash Treaty" on March 28, 2005, by elected officials of six jurisdictions in the Potomac watershed with a goal of a "Trash Free Potomac by 2013;" and

**WHEREAS,** the COG Board of Directors of the Metropolitan Washington Council of Government (COG), at its meeting of May 11, 2005 adopted Resolution R16-05 which endorsed the goal of the Trash Treaty and directed the COG staff to collaborate with the Foundation to achieve that goal; and

WHEREAS, two additional COG-member jurisdictions have either signed on to the Treaty or expressed their intent to do so; and

**WHEREAS**, the Foundation has convened a high-level Advisory Council and a series of Action Teams, both of which have substantial representation from COG staff and COG-member jurisdictions; and

**WHEREAS,** planning is underway to develop a regional Trash-Free Potomac Strategy culminating in a Trash-Free Potomac Summit to be held in spring 2006; and

**WHEREAS,** COG has received a grant from the Summit Fund of Washington to assist the Foundation in the development of the Trash Strategy and the Trash Summit;

## NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE METROPOLITAN WASHINGTON COUNCIL OF GOVERNMENTS THAT:

- 1. The Board reaffirms its support for the goal of achieving a Trash-Free Potomac River by 2013.
- 2. The Board endorses the Foundation's plan to convene a Trash Summit proposed for spring 2006 as well as an effective Trash-Free Potomac Strategy and will encourage members to actively participate in these events and provide support to the public education campaign for the Trash-Free Potomac initiative.
- 3. COG staff will set aside a portion of the COG web site to report on the progress toward development of the Strategy and the Summit.
- 4. COG staff will work with each of the COG jurisdictions to encourage participation in the development and implementation of the regional Trash Strategy and the Trash Summit.
- 5. COG staff will request that each of the COG jurisdictions publicize, via the COG web site, its respective programs and policies aimed a reducing trash that would otherwise end up in local streams and the Potomac River. ----
