# FY 2008 FOR THE TLC PROGRAM

Collowing a positive evaluation of the Transportation/Land-Use Connections (TLC) Program in its pilot phase, the TPB in October approved an amendment to the FY 2008 Unified Planning Work Program (UPWP) to continue and expand the Program.

In FY 2008, the TPB will administer at least eleven technical assistance projects under the TLC Program. The TPB adopted staff recommendations to increase the number of technical assistance projects funded through the Program, from five location-specific projects to at least six of these projects. TPB staff will also maintain and update the TLC website, developed through consultant services during the pilot phase of the TLC Program.

The TPB also will administer funding received through a grant from the Virginia Department of Transportation (VDOT) Multimodal Grant Program. The following

### TPB HOSTS FORUM ON THE TIP

n October 11, the TPB hosted its first annual public forum on the region's six-year Transportation Improvement Program (TIP). The meeting was designed to give citizens a preview of the draft FY2008-2013 TIP and provide background information on the annual process for developing the program.

As required by federal law, the TIP includes all the regionally significant projects that are anticipated to be funded over the next six years. Along with the Constrained Long-Range Plan (CLRP), the TIP is one of the TPB's fundamental planning documents.

### RECOGNITION FOR TPB PROGRAMS

The TPB received an award from the Association of Metropolitan Planning Organization (AMPO) at the 2007 AMPO Annual Conference in early October. The Honorable Mention Award for Excellence in Metropolitan Transportation Planning was presented to the TPB for the Coordinated Human Services Transportation Plan and Program.

The TPB took the initiative in becoming one of the first metropolitan planning organizations (MPO) to serve as a designated recipient for the Federal Transit Administration's (FTA) Job Access Reverse Commute (JARC) and New Freedom programs under the 2005 federal transportation reauthorization legislation (SAFETEA-LU). The TPB achieved consensus on its new role by effectively involving regional transportation partners, human service agencies, private transportation providers and consumer advocates early in the process. The TPB put an emphasis on "customers first," which overcome parochial and helped institutional barriers. Through this award, AMPO acknowledges the TPB's

Coordinated Human Services Transportation Plan as a model for addressing funding challenges and multi-state complexities in other metropolitan areas.

The TPB was presented with the Outstanding Award for an Implemented Program/Tool for the Transportation/Land-Use Connections (TLC) Program at the *National Capital Area Chapter of the American Planning Association (NCAC-APA)* 60th Anniversary and Awards Gala on November 8, 2007. This award is given for a program or tool that is a significant advancement to the planning profession and that fosters greater participation in community planning.

TPB Chair Cathy Hudgins accepted the honor, which was jointly awarded to the TPB for the TLC Program and also to Toole Design Group and the Maryland National Capital Park and Planning Commissions in Montgomery and Prince George's Counties for their work on the Takoma/Langley Crossroads Pedestrian Access and Mobility Study. This Study was completed as part of the pilot phase of the TLC Program for the Counties.

five additional technical assistance projects will be completed in FY 2008 through this VDOT Program:

### City of Alexandria


Review of the Transportation Management Plan Program. The City of Alexandria requested consultant services to review their Transportation Management Plan (TMP) Program and provide recommendations for improving the policy framework and implementation of the Program.

### **Fairfax County**

A Review of Past Land-Use and Transportation Projects. Fairfax County requested consultant services to review several implemented land-use projects that incorporated transportation improvements as part of the development. The final product will provide the County with a survey of the effectiveness of these past projects and recommendations for improving future transportation components.

### **City of Falls Church**

South Washington Street Corridor Planning. The TLC grant will provide the City of Falls Church with technical assistance for corridor planning along South Washington Street, which will complement a

collaborative planning effort between Arlington County and Falls Church around the East Falls Church Metro Station.

### **Town of Leesburg**

An Analysis of Bus Rapid Transit for Leesburg. The Town of Leesburg, through TPB member jurisdiction Loudoun County, requested technical assistance for an analysis of the potential for Bus Rapid Transit (BRT) from Leesburg to the terminus station of the Dulles Metrorail extension.

### City of Manassas Park

City Core Planning and Development. The City requested technical assistance to examine development potential around the planned Park Center development and other land-use opportunities around the Manassas Park Virginia Railway Express (VRE) train station.

The TPB began the TLC Program in FY 2007 with a pilot phase including five location-specific technical assistance projects and one region-wide public presentation on density issues. Projects completed in the pilot phase addressed a wide range of issues linking transportation and land-use. Technical assistance was provide to:

- District of Columbia Office of Planning for a scope of work for a Neighborhood Revitalization Plan for the Potomac Avenue Metro Station,
- Montgomery and Prince George's County Maryland National Capital Park and Planning Commissions for a pedestrian mobility study for the Takoma/Langley Crossroads Sector Plan,
- Charles County for urban roadway standards for the St. Charles Urbanized Area,
- Fairfax County for an analysis of appropriate levels of service around Transit-Oriented Development, and
- Prince William County for a scope of work for a planning study to determine appropriate land-use and transportation actions in response to the Base Realignment and Closure (BRAC) decision.

# TEXAS TRANSPORTATION INSTITUTE DOCUMENTS NATIONWIDE CONGESTION TRENDS



A ccording to the headline-grabbing results of the Texas Transportation Institute's 2007 Urban Mobility Report (TTI Report), the Washington Region's congestion ranks second in the nation. At the TPB's October 17 meeting, Ron Kirby, Director of COG's Department of Transportation Planning, suggested that these annual rankings may distract from the real value of the TTI Report, which is the finding that congestion is getting worse everywhere.

"What is really dramatic about this report is that these trends are going in the same direction everywhere in the country," said Kirby. "That suggests that this has more to do with national policies than it does with what we're doing in this area or any other area." Mr. Kirby emphasized that the primary value of the TTI Report is in studying how urban areas across the country are performing over time. These performance trends are not encouraging. The report authors emphasized that congestion is worse in urban areas of all sizes.

Even though the methodology in the TTI Report has improved over time, Mr. Kirby said it still provides average conditions across a region and it not a substitute for a regional congestion monitoring program which can identify location, direction, and time-specific problem areas. The TPB's Congestion Monitoring Program for highways represents such a study of the Washington area freeway system for morning and evening peak periods. The

Program identifies congestion by location, time, and intensity (including the top ten congested locations). The Congestion Monitoring Program for arterial roadways uses global positioning system (GPS) technology, which provides speed information every two seconds along the arterial roads being studied and helps identify bottlenecks.

In addition, the TPB is currently developing a Congestion Management Process, which will evaluate transportation system performance and compile project-specific congestion management information. The Congestion Management Process will also define, analyze, implement, and assess strategies for improving regional mobility.

Beyond the technical analysis of congestion, there are policy implications that can be drawn from our growing road congestion problems. Traditional federal and state funding sources, such as the gasoline tax, have not kept pace with needs. Much of the responsibility for adding capacity appears to be shifting to local funding sources and tolls.

Two commissions were established under SAFETEA-LU to review congestion and transportation project financing at the national level. *The National Surface Transportation Policy and Revenue Study Commission* is charged with completing a comprehensive study of the national surface transportation system and the Highway Trust Fund. This commission will then develop a conceptual plan with alternative approaches to ensure that this national transportation system continues to serve the needs of the United States. A report is expected in December 2007.

The National Surface Transportation Infrastructure Financing Commission is charged with analyzing future highway and transit needs and the finances of the Highway Trust Fund and making recommendations regarding alternative approaches to financing transportation infrastructure. A report is expected early in 2008. ▲

The 2005 federal transportation reauthorization legislation (SAFETEA-LU) requires metropolitan planning organizations (MPOs) like the TPB to conduct a public meeting during the TIP development process.

The TIP forum featured presentations from the agencies responsible for implementing transportation in the region, including the state departments of transportation and the Washington Metropolitan Area Transit Authority (WMATA). Representatives of these agencies provided insight into their project selection processes and agency revenue streams. The forum was held during the second hour of the regular TPB Citizens Advisory Committee (CAC) meeting.

TPB staff provided information about federal requirements detailing the development of the TIP; financial summaries of transportation funding for the state DOTs and WMATA; and the schedule for approval of the TIP. Representatives from the DOTs of the District of Columbia, Maryland and Virginia (DDOT, MDOT, and VDOT) and WMATA described how projects are developed, prioritized and funded within their jurisdictions. The agency staff discussed the process for

approving a project for construction and opportunities for the public to be involved in the project development process.

The public forum provided an opportunity for citizens to voice their concerns about project development within their jurisdictions. Participants inquired about strategies the agencies use to identify projects of regional significance. Agency staff responded that while most projects are conceptualized at the local or state levels, the agencies have recently been increasing coordination on regional priorities.

Participants also commented that it is difficult for the average citizen to make connections between how the TIP relates to local plans and to the CLRP. They suggested that staff should develop materials to show how the individual projects listed in the TIP fit into the wider regional context. Other questions focused on specific transportation project coordination among the departments of transportation.

The TIP is scheduled to be released for public comment on December 13, along with the 2007 Constrained Long-Range Plan. ▲

They provide information on the TPB's transportation and land-use scenario study, the Regional Mobility and Accessibility Scenario Study. TPB staff will report feedback provided at the District forums to the TPB Scenario Study Task Force to help shape future scenario planning activities and other TPB actions that may be appropriate.

# 2009 MARYLAND TRANSPORTATION PLAN

The Maryland Department of Transportation (MDOT) is updating its Statewide Long-Range Transportation Plan, known as the Maryland Transportation Plan (MTP). This plan establishes a 20-year vision for transportation in Maryland and helps guide statewide improvements across all means of transportation, including highways, roads, tunnels, bridges, trains, buses, water ports, airports, bike paths, and sidewalks.

MDOT updates the MTP every five years to address current and future transportation challenges, needs and conditions and strives to create a plan that reflects and responds to Maryland's residents, businesses, local governments, and communities. MDOT is conducting extensive public outreach to engage you, as a user of the Maryland transportation system, as well as numerous other citizens, agencies, and interested organizations to help revise the long-range vision, goals, and objectives of the MTP.
