MWAQC Priorities

- Develop an attainment State Implementation Plan (SIP) and/or MP/RR for the 2015 ozone NAAQS.
- Track monitoring data and EPA actions to determine the area's designation status for the 2015 ozone NAAQS.
- Work with members to identify and implement initiatives to reduce air pollution.
- Track regulatory actions related to transport of pollution and comment when appropriate.
- Transportation Conformity
 - Review & comment on transportation conformity assessments for ozone
- Communicate to regional and local leaders and the public on improvements to air quality and the need for actions to reduce emissions and improve air quality.



CEEPC Priorities

- Continue participating in the GCoM Metro Scale Climate Leaders.
- Support local climate action plan development, emphasizing both mitigation and resiliency.
- Enhance regional climate collaborative website, DMV Climate Partners.
- Develop draft and final GHG emission calculations for the 2020 community-scale greenhouse gas local and regional inventories. Coordinate with ICLEI to incorporate carbon sequestration calculations and update Contribution Analysis modeling to gauge why GHG emissions are changing overtime.



CEEPC Priorities

- Collect and analyze utility energy data for the region. Analyze renewable energy trends within the COG region.
- Coordinate local participation in and technical support for the Maryland Energy Administration Streetlights Program.
- Continue efforts to expand cooperative purchasing of solar, energy supplies, and other related equipment and services for local government operations and in communities.
- Continue regional EV readiness planning to support broader EV infrastructure deployment. Support local government EV planning efforts.
